### ORDER:

In his letter second read above, the Director of Rural Development and Panchayat Raj has stated that the Government of India in their letter 1<sup>st</sup> read above have sanctioned a sum of Rs.10,22,89,000/- (Rupees Ten Crore Twenty Two lakh and Eighty Nine Thousand only) as part of 1<sup>st</sup> installment of 1<sup>st</sup> tranche to the State Government of Tamil Nadu as Central Assistance towards conducting Social Audit in the State and staffing of independent Social Audit Unit for the financial year 2021-22.

2. The Government of India have also requested the State Government to transfer the funds to the Social Audit Unit's Bank account within 15 days of receipt of the funds and provide the Ministry with a certificate denoting the transfer of funds to the Social Audit Unit Account as below:-

Therefore, the Director of Rural Development and Panchayat Raj has requested orders of the Government to sanction a sum of Rs.10,22,89,000/- as part of 1<sup>st</sup> installment of 1<sup>st</sup> Tranche to the State Government of Tamil Nadu as Central Assistance towards conducting Social Audit in the State and staffing of independent Social Audit Unit for the financial year 2021-22 and to permit him to draw and transfer the amount to the Social Audit Society of Tamil Nadu (SASTA).

4. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction for a sum of Rs.10,22,89,000/- (Rupees Ten Crore Twenty Two Lakh and Eighty Nine Thousand only) as part of 1<sup>st</sup> installment of 1<sup>st</sup> Tranche as Central Assistance towards conducting Social Audit in the State and staffing of independent Social Audit Unit for the financial year 2021-22.

He is directed to include this item of expenditure while sending the budget proposal for RE/FMA 2021-2022 and also send necessary draft explanatory note for inclusion of this expenditure in the supplementary Estimates 2021-2022 to Government in Finance (RD/B.G-1) Department at the appropriate time without fail.
