



## ABSTRACT

Mahatma Gandhi National Rural Employment Guarantee Scheme – Announcement made by Hon'ble Chief Minister under Rule 110 on the floor of the Legislative Assembly on 19.3.2020 – Construction of Cement Concrete Pavement, Paver Block Pavement and Culverts / Cross Drainage Structures in Rural Areas at a total cost of Rs.636.71 crore under MGNREGS for the year 2020-21 – Permission accorded – Orders – Issued.

### ORDER:

The Honourable Chief Minister of Tamil Nadu has made the following two Announcements under Tamil Nadu Legislative Assembly Rule 110 on 19.03.2020:

1. ஊரகப் பகுதிகளில் உள்ள குறுகலான தெருக்கள் மற்றும் பாதைகளை தரம் உயர்த்தும் பொருட்டு, 2020-21 ஆம் நிதி ஆண்டில் 350 கி.மீ. நீளத்திற்கு சிமெண்ட் கான்கிரீட் சாலைகளும், 200 கி.மீ. நீளத்திற்கு பேவர் பிளாக் சாலைகளும், 213 கோடியே 26 லட்சம் ரூபாய் மதிப்பீட்டில் அமைக்கப்படும். மேலும் ஊரகப் பகுதிகளில் போக்குவரத்தை மேம்படுத்தவும், நீர்நிலைகளைக் கடந்திடவும் ஏதுவாக 850 குறுபாலங்களும், 350 சிறு பாலங்களும் என மொத்தம் 1,200 சிறு, குறுபாலங்கள் 170 கோடியே 18 லட்சம் ரூபாய் மதிப்பீட்டில் கட்டப்படும்.
2. ஆதிதிராவிடர் குடியிருப்புப் பகுதிகளில் அனைத்து அடிப்படை வசதிகளையும் மேம்படுத்திட வேண்டும் என்ற உயரிய நோக்கில், பல்வேறு திட்டங்களை ஒருங்கிணைத்து உரிய நிதி ஒதுக்கீடு செய்து, அதனை செயல்படுத்தும் விதத்தில், 2020-21 ஆம் ஆண்டைய நிதிநிலை அறிக்கையில் வழிவகை செய்யப்பட்டுள்ளது. அதன்படி, மகாத்மா காந்தி தேசிய ஊரக வேலை உறுதியளிப்புத் திட்டம், மத்திய, மாநில

நிதிக்குழுவின் நிதி மற்றும் அம்மா ஆதிதிராவிடர் குடியிருப்பு மேம்பாட்டு திட்ட நிதி ஆகியவற்றில் இருந்து 2,500 கோடி ரூபாய் ஒதுக்கீடு செய்யப்படும். இந்நிதியில் இருந்து, ஆதிதிராவிடர் குடியிருப்பு பகுதிகளில் குடிநீர் வசதி, இணைப்புச் சாலை வசதி, சிமெண்ட் / பேவர் பிளாக் சாலை வசதி, தெருவிளக்குகள், வடிகால் வசதி, மயான மேம்பாடு உள்ளிட்ட அடிப்படை வசதிகள் ஏற்படுத்தப்படும் என்பதை மகிழ்ச்சியுடன் இப்பேரவைக்கு தெரிவித்துக் கொள்கிறேன்.

2. Based on the above announcement, the Director of Rural Development and Panchayat Raj in the reference 2<sup>nd</sup> read above has sent a proposal stating that the Ministry of Rural Development, Government of India, has approved Labour Budget of 27 Crore persondays under Mahatma Gandhi National Rural Employment Guarantee Scheme to Tamil Nadu for the financial year 2020-21. The Para 4(1)IV(ii) Schedule-I of the **National Rural Employment Guarantee Act, 2005** states that "Providing all-weather rural road connectivity to unconnected villages and to connect identified rural production centres to the existing pucca road network; and construction of pucca internal roads or streets including side drains and culverts within a village;". In the "Permissible Works List" communicated by Ministry of Rural Development, Government of India, the construction of Cement Concrete Roads for community has been listed at Sl.No.198 under Category D, Interlocking Paver Block pavements for community has been listed at Sl.No.194 under Category D and the Construction of Culverts/Cross Drainage structures for community have been listed at Sl.No.100 under Category D. Accordingly, it is proposed to undertake the works under MGNREGS during the financial year 2020-21 as detailed below.

1. 700 km of Cement Concrete Pavement at a total cost of Rs. 258.37 Crores during the financial year 2020-21 under Mahatma Gandhi National Rural Employment Guarantee Scheme. In the total target, 50% reservation i.e., 350 km will be given exclusively for the Adi Dravidar habitations as per the announcement made by Hon'ble Chief Minister as above.
2. 400 km of Interlocking Paver Block Pavement at a total cost of Rs.168.16 Crores during the financial year 2020-21 under Mahatma Gandhi National Rural Employment Guarantee Scheme. In the total target, 50% reservation in the above target i.e., 200 km will be given exclusively for the Adi Dravidar habitations as per the announcement made by Hon'ble Chief Minister as above.
3. 450 units of 1.5m Span Culvert, 400 units of 3.00m Span Culvert, 350 units of Minor Bridges during the financial year 2020-21 as standalone works under Mahatma Gandhi National Rural Employment Guarantee Scheme. Further, 2,000 units of culverts exclusively for streets in Adi Dravidar habitation is to be taken-up as per the announcement made by Hon'ble Chief Minister as above.

3. The Director of Rural Development and Panchayat Raj has further stated that the above works was approved by the Empowered Committee, Ministry of Rural Development, Government of India during the Empowered committee Meeting held on 13.03.2020. The Government of India have notified the wage rate for the financial year 2020-21 as Rs.256/- per day in respect of Tamil Nadu. Accordingly, the revision of wage rate and the Rural Schedule of Rate (RSoR) was approved for the financial

year 2020-21 in G.O.(Ms).No.82, Rural Development and Panchayat Raj (CGS.1) Department, Dated:30.03.2020 and G.O.(Ms).No.86, Rural Development and Panchayat Raj (CGS.1) Department, dated:13.04.2020 respectively and the Rural Schedule of Rate 2020-21 is adopted for this work. G.O.(Ms.)No.127, Rural Development and Panchayat Raj Department (CGS-1), dated 12.09.2018 issued for Cement Concrete Pavement, G.O.(Ms.)No.130, Rural Development and Panchayat Raj (CGS-1) Department, dated 12.09.2018 issued for Paver Blocks and G.O.(Ms.)No.120, Rural Development and Panchayat Raj (CGS-1) Department, dated 05.09.2018 issued for the construction of Culverts and Minor bridges shall be adopted for the year 2020-21 also and referred for Planning, selection of work, execution of above works and Non-negotiable items without any deviation.

#### **Work Selection in Adi Dravidar Habitations:**

- The Project Director (DRDA) should use the THAI survey report as the basic data and identify the requirement of all the SC inhabited areas in the district through the Block Development Officer (BP) concerned.
- The Project Director (DRDA) should prioritize and prepare the list of SC habitations to be covered under this scheme in a particular year based on descending order of SC population in the district.
- Selection of sites shall be based on descending order of population.
- **“Atrocity prone villages”** identified by Additional Director General of Police, Social Justice and Human Rights **should compulsorily be taken up, irrespective of the population.**
- Only after exhausting the requirement of atrocity prone villages in the blocks of the districts, the works in other Adi Dravidar habitations should be undertaken, based on descending order of population.

#### **Non-Negotiable Items:**

1. Citizen Information Board shall be kept at the work site in 3 X 4 feet with all necessary information as per the framework given by the Government of India vide Ref No:k11023/1/1/2017 – MGNREGA (IV), MORD, Dated 07.04.2017. The cost of Citizen Information Board will be fixed at **Rs.4,500/- per unit** The cost of the Citizen Information Board shall be included in the estimate itself.
2. Wherever the work is taken-up in the Adi dravidar habitations, the logo and emblem as per G.O.(Ms.)No.190, Rural Development and Panchayat Raj (PR.3) department, dated:31.12.2019 shall be done on the other side of the Mahatma Gandhi National Rural Employment Guarantee Scheme Citizen Information Board at an additional cost of **Rs.500** for acrylic painting and logo/emblem tiles. The cost of the information board shall be included in the estimate itself to the tune of **Rs.5,000/-** for works taken-up in the Adi-dravidar habitations.
3. Estimate creation, Administrative sanction and Technical sanction shall be done in SECURE software.
4. The Notified Wage Rate as per G.O.(Ms.) No.82, Rural Development and Panchayat Raj (CGS.1) Department, Dated: 30.03.2020 and the Rural Schedule of Rates finalised in G.O.(Ms.)No.86, Rural Development and Panchayat Raj (CGS.1) Department, Dated:13.04.2020 shall be adopted. In

case of any revision made in Rural Schedule of Rates in future, the same shall be adopted.

4. The Director of Rural Development and Panchayat Raj has worked out the funding pattern as follows:

### 1. Cement Concrete Pavement

700 Km of Cement Concrete Pavement will be constructed at an estimated cost of Rs.258.37 Crore at a unit cost Rs.36.91 Lakhs per Km during the financial year 2020-21 under Mahatma Gandhi National Rural Employment Guarantee Scheme. Out of which the Labour Component is Rs.29.02 Crore and Material Component is Rs.229.35 Crore with Labour Material ratio of 11.23:88.77.

### 2. Paver Block Pavement

400 Km of Paver Block Pavement will be constructed at an estimated cost of Rs.168.16 Crore at a unit cost Rs.42.04 Lakhs per Km. Out of which the Labour Component is Rs.14.04 Crore and Material Component is Rs.154.12 Crore with Labour Material ratio of 8.35:91.65.

### 3. Culverts and Minor Bridge

450 units of 1.5m Span Culvert, 400 units of 3.00m Span Culvert, 350 units of Minor Bridges 1 as standalone works under Mahatma Gandhi National Rural Employment Guarantee Scheme and 2,000 units of culverts exclusively for streets in Adi-Dravidar habitation will be constructed under Mahatma Gandhi National Rural Employment Guarantee Scheme during the financial year 2020-21.

The unit cost for the above works is calculated based on the Standard type design and Rural Schedule of Rates 2020-21. However, the actual estimate may vary according to the site condition. The Labour cost is borne 100% by the Government of India and the material cost is shared at the ratio of 75:25 by the Government of India and the State Government.

5. The Director of Rural Development and Panchayat Raj has therefore requested the Government to accord permission for construction of 350 Km of Cement Concrete Pavement in SC habitation and 350 Km in other habitations totally 700 Km of Cement Concrete Pavement, 200 Km of Paver Block Pavement in SC habitation and 200 Km in other habitations totally 400 Km of Paver Block Pavement, 450 units of 1.5m Span Culvert, 400 units of 3.00m Span Culvert, 350 units of Minor Bridges and 2,000 units of culverts exclusively for streets in Adi-Dravidar habitation at a total estimated cost of Rs.636.71 Crore as per the announcement of Hon'ble Chief Minister during the financial year 2020-21 under Mahatma Gandhi National Rural Employment Guarantee Scheme.

6. The Government, after careful examination, have decided to accept the proposal of Director of Rural Development and Panchayat Raj and accord permission for construction of 350 Km of Cement Concrete Pavement in SC habitation and 350 Km in other habitations totally 700 Km of Cement Concrete Pavement, 200 Km of Paver Block Pavement in SC habitation and 200 Km in other habitations totally 400 Km of Paver Block Pavement, 450 units of 1.5m Span Culvert, 400 units of 3.00m Span Culvert, 350 units of Minor Bridges and 2,000 units of

culverts exclusively for streets in Adi-Dravidar habitation at a total estimated cost of Rs.636.71 Crore, subject to the condition that the financial sanction shall be approved after getting the release of Central Share.
