ORDER:

In the G.O. first read above, the Government have sanctioned a sum of Rs.15,01,00,000/- as 1st installment of 1st Tranche of Central and State share for Material Component for the year 2019-20 under Mahatma Gandhi National Rural Employment Guarantee Scheme. In the G.O. second read above, the Government have sanctioned a sum of Rs.104,31,81,333/- as 2nd installment of 1st Tranche of Central and State share for Material Component for the year 2019-20 under Mahatma Gandhi National Rural Employment Guarantee Scheme.

2. In the letter third read above, the Director of Rural Development and Panchayat Raj has stated that the Empowered Committee has agreed to the Labour Budget of 22.00 Crore persondays for the State of Tamil Nadu for the year 2019-20. The Government of India in the Letter No.J-12034/2/2019-RE-VI, SI.No.59. dt.05.08.2019 have sanctioned a sum of Rs.598,35,23,000/- (Rupees Five Hundred Ninety Eight Crore Thirty Five Lakh and Twenty Three Thousand only) towards material component and a sum of Rs.89,75,28,000/- (Rupees Eighty Nine Crore Seventy Five Lakh and Twenty Eight Thousand Only) towards Admin component as 3rd installment of 1st Tranche of Central Assistance for implementation of the Mahatma Gandhi National Rural Employment Guarantee Act for the financial year 2019-20 on condition that the State Government must transfer these funds to the State Employment Guarantee Fund for programme implementation within 3 days of receipt of funds failing which the State Government would be liable to pay a penal interest of 12% for the period of delay beyond the specified period. In the G.O. fourth read above, the Government have sanctioned a sum of Rs.797,80,30,667/- as 3rd installment of 1st Tranche of Central and State share for Material component for the year 2019-20 under Mahatma Gandhi National Rural Employment Guarantee Scheme.

- 3. The Director of Rural Development and Panchayat Raj has therefore requested the Government to sanction a sum of Rs.89,75,28,000/- (Rupees Eighty Nine Crore Seventy Five Lakh and Twenty Eight Thousand only) towards Admin cost as 3rd installment of 1st Tranche of Central Assistance for the year 2019-20 under Mahatma Gandhi National Rural Employment Guarantee Scheme and requested to permit him to draw and transfer the amount to the State Employment Guarantee Fund of Tamil Nadu.
- 4. The Government after careful examination have decided to accept the proposal of the Director of Rural Development and Panchayat Raj and release a sum of Rs.39,34,53,833/- (Rupees Thirty Nine Crore Thirty Four Lakh Fifty Three of Rs.39,34,53,833/- (Rupees Thirty Nine Crore Thirty Four Lakh Fifty Three of Rs.39,34,53,833/- (Rupees Thirty Nine Crore Forty Lakh Seventy Four sanction a sum of Rs.50,40,74,167/- (Rupees Fifty Crore Forty Lakh Seventy Four Thousand One Hundred and Sixty Seven only) additionally by specific inclusion in R.E / FMA 2019-20 totally a sum of Rs.89,75,28,000/- (Rupees Eighty Nine Crore Seventy Five Lakh and Twenty Eight Thousand only) towards Admin cost as 3rd installment of 1st tranche of Central Assistance for the year 2019-20 under Mahatma Gandhi National Rural Employment Guarantee Scheme.
