ORDER:

In the Government Order first read above, orders along with detailed Guidelines were issued for the implementation of Member of Legislative Assembly Constituency Development Scheme (MLACDS) for the year 2019-2020. In the Government Order second read above, orders were issued for enhancing the funds from Rs.2.50 crore to Rs.3.00 crore along with revised Guidelines for the implementation of the above scheme for the year 2019-2020. In the Government Order third read above, the Government has given permission for allocation of a minimum amount of Rs.25 lakh by the Members of Legislative Assembly under the Member of Legislative Assembly Constituency Development Scheme for purchase of equipments for Government Hospitals / Dispensaries for medical testing, screening and other facilities required to detect and contain COVID-19 and the expenditure under the one time dispensation

shall be met from the un-sanctioned amount available for the year 2019-20 and otherwise, it shall be adjusted for the allocation of the financial year 2020-21.

2. In the Government Order fourth read above, orders were issued to reduce the per MLA allotment in Budget Estimate 2020-21 to Rs.2 crore by way of reduction in appropriation and allocate to the tune of Rs.235 crore at the rate of Rs.1 crore per MLA from the MLACDS funds to the Health and Family Welfare Department for procuring medicines and materials to detect and contain COVID-19 through Tamil Nadu Medical Services Corporation (TNMSC).

3. The Director of Rural Development and Panchayat Raj has, therefore, sent necessary proposal along with draft guidelines and requested the Government to issue necessary Government Orders for the implementation of Member of Legislative Assembly Constituency Development Scheme (MLACDS) along with fund allocation of Rs.2 crore per Constituency per annum for the year 2020-21 in which Rs.1 crore for "tied component" and Rs.1 crore for "un-tied component".

4. The Government have carefully examined the proposal of the Director of Rural Development and Panchayat Raj in detail. Accordingly, the Government issues the following orders:-

- (i) Administrative sanction is accorded for a sum of Rs.470.00 crore (Rupees four hundred and seventy crore only) for the implementation of Member of Legislative Assembly Constituency Development Scheme (MLACDS) for the year 2020-21;
- (ii) Detailed guidelines both in English and Tamil for the implementation of Member of Legislative Assembly Constituency Development Scheme (MLACDS) for the year 2020-21 is annexed to this order.
