Announcement made by Hon'ble Minister for Municipal Administration, Rural Development and Implementation of Special Programme on the floor of the Legislative Assembly on 21.06.2017 - Construction of Compound Wall / Flood Control and Protection Wall to School Buildings for a length of 100 Kms at a total cost of Rs.50 crore under MGNREGS during the year 2017-18 - Permission accorded - Orders - Issued.

## **ORDER:**

The Hon'ble Minister (Municipal Administration, Rural Development and Implementation of Special Programme) has made the following announcement on the floor of the Legislative Assembly on 21.06.2017:-

மாண்புமிகு இதயதெய்வம் புரட்சித் தலைவி அம்மா அவர்களின் ஆசியுடன், மாண்புமிகு முதலமைச்சர் அவர்களின் ஆணைப்படி, ஊரகப் பகுதிகளில் உள்ள ஆரம்பப்பள்ளி மற்றும் நடுநிலைப்பள்ளி கட்டடங்களுக்கு சுற்றுச் சுவர் மற்றும் வெள்ளத் தடுப்புச் சுவர் 50 கோடி ரூபாய் மதிப்பீட்டில் கட்டப்படும்.

2. In the letters second read above, the Director of Rural Development and Panchayat Raj has stated that Revised Schedule I of the National Rural Employment Guarantee Act, 2005 Paragraph 4 (1) IV Category-D: Rural Infra Structure provides "works for improving disaster preparedness or restoration of roads or restoration of other essential public infrastructure including flood control and protection works providing drainage in water logged areas, deepening and repairing of flood channels, chaur renovation, construction of storm water drains for coastal protection". The construction of Compound wall / Flood Control and Protection Wall to School Buildings is a permitted

activity as per Sl.No.142 of the list of identified works permissible under MGNREGA communicated by the Ministry of Rural Development, Government of India in Letter F.No-J-11011/07/2016-RE-I(351427), Dated: 14.10.2016.

3. The Director of Rural Development and Panchayat Raj has also stated that the norms to be followed while construction of Compound Wall/Flood Control and Protection Wall to Panchayat Union Elementary School and Panchayat Union Middle School Buildings to a total length of 100 Kms at a total cost of Rs.50.00 crore under Mahatma Gandhi National Rural Employment Guarantee Scheme during the year 2017-18 is as follows:-

- (1) The Compound Wall/Flood Control and Protection Wall shall be constructed for Panchayat Union Elementary School and Panchayat Union Middle School only which are located in village panchayat area and also under the maintenance of Panchayat Union.
- (2) The List of Schools and length of Compound Wall/Flood Control and Protection Wall shall be obtained from the School education department Officials i.e Chief Education Officer, District Elementary Education Officer of the concerned districts.
- (3) The priority shall be given to schools based on the students strength, schools abutting the road, the schools which have compound walls on 2 sides in school built under any other Schemes.
- (4) The Rural Schedule of Rate finalised in G.O(Ms) No.45, Rural Development and Panchayat Raj(CGS.1) Department, Dated: 03.04.2017 shall be adopted. In case of any revision made in Rural Schedule of Rates in future, the same shall be adopted.
- (5) Photographs shall be taken before execution, during execution and after completion of work.
- (6) Citizen Information Board shall be kept at the work site in 2 X 3 feet with all necessary information as per the framework given by the Government of India vide Ref No:k11023/1/12017-MGNREGA(IV), MORD, Dated 07.04.2017. The cost of the information board shall be included in the estimate itself.
- (7) Geo Tagging of the Assets shall be done after completion of the work.
- (8) All the work sites should have MGNREGS work file (Checklist/ Contents) as per the instructions of GoI, vide Ref No: J11001017/6/12016-MGNREGA (VII), MORD, Dated 21.12.2016.

4. The Director of Rural Development and Panchayat Raj has also stated that the material component of Compound Wall / Flood Control and Protection Wall for a length of 1 Km will be Rs.44,14,480 and Labour Component will be Rs.5,85,520 for generating 2856 Person days. Further, the Director of Rural

Development and Panchayat Raj has worked out the funding pattern for the construction of Compound Wall/Flood Control and Protection Wall to a length of 100 Kms under MGNREGS for the year 2017-18 as follows:

The Director of Rural Development and Panchayat Raj has therefore requested the Government to accord permission for the construction of Compound Wall / Flood Control and Protection Wall (100m to 250m) to Panchayat Union Elementary School and Panchayat Union Middle School Buildings for a total length of 100 Kms at a total cost of Rs.50.00 crore under Mahatma Gandhi National Rural Employment Guarantee Scheme during the year 2017-18.

6. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord permission for the construction of Compound Wall / Flood Control and Protection Wall (100m to 250m) to Panchayat Union Elementary School and Panchayat Union Middle School Buildings for a total length of 100 Kms at a total cost of Rs.50.00 crore under Mahatma Gandhi National Rural Employment Guarantee Scheme during the year 2017-18.
