Mahatma Gandhi National Rural Employment Guarantee Act - Payment of 1st part of 2nd Tranche of Central Assistance of Material and administrative Component released by Government of India - Sanction a sum of Rs.25,00,00,000/- under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2017-18 - Sanction accorded – Orders- Issued.

ORDER:

In the letter read above, the Director of Rural Development and Panchayat Raj has stated that the Empowered Committee after scrutiny has agreed to the Labour Budget proposal of 23.33 crore persondays for the State of Tamil Nadu for the year 2017-18 in the Letter No.J-12034/2/2017-MGNREGS-VI SI.No.16(NeFMS), dated 10.04.2017, SI.No.31(NeFMS) dated 21.07.2017, SI.No.47(NeFMS), dated 21.07.2017 and Sl.No.62 (NeFMS) dated 20.09.2017, Government of India have released a sum of Rs.4050.20 crore as Mother Sanction order to the Ne-FMS account for implementation of National Electronic Fund Management System(NeFMS) under MGNREGA towards Wage Component for the financial year 2017-18 out of which a sum of Rs 3995.10 crore has been released so far. Further, a sum of Rs.255.79 crore (Rs.70.89 crore + Rs.70.89 crore + Rs.57 crore + Rs.57 crore) has been released by Government of India as Central Assistance towards material component and Rs.72.10 crore (Rs36.048 crore + Rs.36.048 crore) towards Admn. Component being 4th and 5th part of 1st tranche of Central Assistance vide Government of India, SI.No:69 dated:26.05.17, No:J-12034/2/2017-MGNREGS-VI SI.No:47 dated:30.06.2017, Sl.No:98 dated: 21.7.2017 and Sl.No:116, dated:22.07.2017 respectively.

2. Subsequently, the State Government vide G.O.(Ms).No: 65, Rural Development and Panchayat Raj (CGS.1) Department, dated: 16.6.2017, G.O.(Ms).No:89, Rural Development and Panchayat Raj (CGS.1) Department, dated: 01.8.2017, G.O.(Ms) No:97, Rural Development and Panchayat Raj (CGS.1) Department, dated: 01.9.2017, G.O.(Ms) No:103, Rural Development and Panchayat

Raj (CGS.1) Department, dated:18.09.2017 have sanctioned a sum of Rs.255.79 crore (Rs.70.89 crore + Rs.70.89 crore + Rs.57 crore + Rs.57 crore) towards Material component and Rs.72.10crore (Rs36.048 crore + Rs.36.048 crore) towards Admin component being 2nd ,3rd, 4th and 5th part of 1st tranche of Central Assistance alongwith the proportionate 25% State Share of Rs.85.26 crore (Rs.23.63 crore +Rs.23.63 Crore +Rs.19 crore) respectively for the year 2017-18 under Mahatma Gandhi National Rural Employment Guarantee Scheme.

- 3. The Government of India in Letter No.J-12034/2/2017-MGNREGA-VI, SI.No.156, Dated 02.11.2017 have sanctioned a sum of Rs.25.00 Crore (Rupees Twenty Five Crore only) to the State Government of Tamil Nadu as 1st part of 2nd Tranche of Central Assistance towards Material component and Admin component for implementation of the MGNREGA for the financial year 2017-18 on condition that the State Government must transfer these funds along with the State share to the State Employment Guarantee Fund for programme implementation within 3 days of receipt of funds failing which the State Government would be liable to pay a penal interest of 12% for the period of delay beyond the specified period.
- 4. The Director of Rural Development and Panchayat Raj has further stated that as per para 16.2 administrative expenses of Master Circular 2017-18 of MGNREGA upto 6% of the total expenditure under Mahatma Gandhi NREGA in a financial year can be utilized for Administrative expenses. Hence, considering the release amount as 36% Government of India share, out of the amount of Rs.25 Crore (Rupees Twenty Five Crore only), Rs.4,16,66,667/- (Rupees Four Crore Sixteen Lakh Sixty Six Thousand Six Hundred and Sixty Seven only) is arrived as 6% for Administrative Component and Rs.20,83,33,333/- (Rupees Twenty Crore Eighty Three Lakh Thirty Three Thousand Three Hundred and Thirty Three only) towards 30% Material component. Further, as per para 3(f) of the above Government of India order, it has been ordered that the expenditure of material component including wages of skilled and semi-skilled labour will be shared between Centre and State Government in the ratio of 75:25 in accordance with Rule 22(1)(b) and (2)(b) of the NREGA Act 2005. Therefore, taking into account of the above release of material component as 75% share of Government of India, the State has to bear the balance 25% of the cost of the material component which amounts to Rs.6,94,44,444/- (Rupees Six Crore Ninety Four Lakh Ninety Four Thousand Four Hundred and Forty Four only).
- 5. The Director of Rural Development and Panchayat Raj has therefore requested the order of the Government on the following:
 - i. to sanction a sum of Rs.20,83,33,333/- (Rupees Twenty Crore Eighty Three Lakh Thirty Three Thousand Three Hundred and Thirty Three only) towards Material component as 1st part of 2nd tranche of Central Assistance along with the proportionate State Share Rs.6,94,44,444/- (Rupees Six Crore Ninety Four Lakh Forty Four Thousand Four Hundred and Forty Four only)for the year 2017-18 towards Material component and admin cost Rs.4,16,66,667/- (Rupees Four Crore Sixteen Lakh Sixty Six Thousand Six Hundred and Sixty Seven only) total amount of Rs.31,94,44,444/- (Thirty One Crore Ninety Four Lakh Forty Four

Thousand Four Hundred and Forty Four only) under Mahatma Gandhi National Rural Employment Guarantee Scheme.

- ii. to permit the Director of Rural Development and Panchayat Raj to draw and transfer the amount to the State Employment Guarantee Fund of Tamil Nadu.
- 6. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction for a sum of Rs.31,94,44,444/-(Rupees Thirty One Crore Ninety Four Lakhs Forty Four Thousand Four Hundred and Forty Four only) [Rs.25,00,00,000/- (Rupees Twenty five Crore only) towards Material Component and Administrative component as 1st part of 2nd Tranche of Central Share along with proportionate State Share of Rs.6,94,44,444/-] under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2017-18.
- 7. The expenditure sanctioned in para 6 above shall be debited to the following head of account:
