ORDER:

In the letter first read above, Ministry of Rural Development accorded a clearance for upgradation of 299 roads for a length of 1,044.04 Km at a total cost of Rs.553.07 crore, out of which Central Share is of Rs.331.62 crore and State Share is of Rs.221.45 crore. In the Government Order second read above, the Government accorded Administrative Sanction for upgradation of 299 roads for a length of 1,044.04 Km at a total cost of Rs.553.07 crore under PMGSY-III Batch-I (2019-20).

2. In the Government Order third read above, the Government accorded a sanction and released a sum of Rs. 183,46,00,000/- towards Programme Fund under PMGSY III, Batch I (2019-2020) for the year 2021-22.

3. In the letter fourth read above, the Ministry of Rural Development released a sum of Rs.110,00,00,000/- to the State Government as Central assistance towards 1st tranche of 2nd instalment of Programme Funds under PMGSY-III, Batch-I (2019-20) for the year 2021-22. Moreover, it has been stated that the State Government shall transfer the Central assistance along with the corresponding State Share to Tamil Nadu Rural Housing and Infrastructure Development Corporation (TNRHIDC).

4. In pursuance of the above release of funds in the letter fifth read above, the Director of Rural Development and Panchayat Raj, has requested the Government to issue necessary orders on the following:-

- i) To release a sum of Rs.183,46,00,000/- [Rs.110,00,00,000/- as Central Share and Rs.73,46,00,000/- as State Share] towards 1st tranche of 2nd instalment of Programme Funds under PMGSY-III, Batch-I (2019-20) for the year 2021-22.
- ii) To authorize the Director of Rural Development and Panchayat Raj to draw the sanctioned amount from Pay and Accounts Office(South) and to transfer the same to Tamil Nadu Rural Housing and Infrastructure Development Corporation account.

5. The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, have decided to accept the same. Accordingly, the Government accord sanction and release a sum of Rs.183,46,00,000/- (Rupees One Hundred Eighty Three crore and Forty Six lakh Only) [Rs.110,00,00,000/- as Central Share and Rs.73,46,00,000/- as State Share] towards 1st tranche of 2nd instalment of Programme Funds under PMGSY-III, Batch-I (2019-20) for the year 2021-22.

6. The expenditure sanctioned in para 5 shall be debited under the following heads of account:
