## ORDER:

The Hon'ble Minister for Municipal Administration, Rural Development and Implementation of Special Programme has made the following announcement on the floor of the Legislative Assembly on 08.07.2019.

2. In the letter second read above, the Director of Rural Development and Panchayat Raj has stated that, Government of India, Ministry of Rural Development has approved Labour Budget of 22 Crore persondays under Mahatma Gandhi National Rural Employment Guarantee Scheme to Tamil Nadu for the financial year 2019-20 and the Revised Schedule I of the National Rural Employment Guarantee Act, 2005 Paragraph 4(1) IV Category-D: (v) permits the construction of buildings for Gram Panchayats, Women Self-help groups, federations, cyclone shelters, Anganwadi Centres, Village haats and crematoria at the Village or Block Level and also in Master Circular 2018-19 at 7.5.2 construction of Anganwadi as works require special focus. Accordingly, the Director of Rural Development and Panchayat Raj has now proposed to construct 1303 Anganwadi Centre Buildings at an unit cost of Rs.9.08 lakh (Rs.5.00 lakh under Mahatma Gandhi National Rural Employment Guarantee Scheme, Rs.2.00 lakh

under Integrated Child Development Service Scheme (ICDS) from Social Welfare Department and Rs.2.08 lakh from Panchayat Union General Fund or Panchayat General Fund) under Mahatma Gandhi National Rural Employment Guarantee Scheme in convergence with Integrated Child Development Services Scheme (ICDS) and Panchayat Union General Fund or Panchayat General Fund at a total cost of Rs.118.31 crore to provide nutrition to children from two to five years and supplementary nutrition to pregnant and lactating mothers preschool education, health and to inculcate the habit of personal hygiene in children, adolescents, pregnant and nursing mothers. The above work has been proposed in the Labour Budget for the financial year 2019-20 and the same was approved by the Empowered Committee, Ministry of Rural Development, Government of India during the Empowered Committee Meeting held on 18.02.2019.

- 3. The Director of Rural Development and Panchayat Raj has also stated that the Government of India have notified the wage rate for the financial year 2019-20 as Rs.229/- per day in respect of Tamil Nadu. Accordingly, the Rural Schedule of Rates for the year 2019-20, approved in G.O.(Ms).No.52, Rural Development and Panchayat Raj (CGS.1) Department, dated:09.04.2019 and G.O.(Ms).No.53, Rural Development and Panchayat Raj (CGS.1) Department, dated:15.04.2019 are adopted for this work. The detailed guidelines issued vide G.O.(Ms).No.125, Rural Development and Panchayat Raj (CGS.1) Department, dated:12.09.2018 for the construction of Anganwadi Centres shall be adopted and referred for Planning, selection of work, Type Design, non-negotiable items and Technical Specification without any change.
- 4. The Director of Rural Development and Panchayat Raj has further stated that the unit cost of Anganwadi Centre will be Rs.9.08 lakh (Rs.5.00 lakh under Mahatma Gandhi National Rural Employment Guarantee Scheme, Rs.2.00 lakh under Integrated Child Development Services Scheme (ICDS) from Social Welfare Department and Rs.2.08 lakh from Panchayat Union General Fund or Panchayat General Fund) The Labour cost is 100% borne by the Government of India and the material cost is shared at the ratio of 75:25 by the Government of India and the State Government. The Director of Rural Development and Panchayat Raj has worked out the funding pattern for Construction of 1303 Anganwadi Centre buildings in Convergence with Social Welfare Department at a total cost of Rs.118.31 crore in Rural areas under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2019-20 as detailed below:

The Director of Rural Development and Panchayat Raj has requested permission from the Government for the construction of 1303 New Anganwadi Centres in convergence with Integrated Child Development Services Scheme (ICDS) at a total cost of Rs.118.31 Crore which includes Rs.65.15 crore under Mahatma Gandhi National Rural Employment Guarantee Scheme, Rs.26.06 crore under Social Welfare Department and Rs.27.10 crore under Panchayat Union General Fund or Panchayat General Fund for the year 2019-20 and also to adopt the guidelines issued vide G.O.(Ms).No.125, Rural Development and Panchayat Raj (CGS.1) Department, dated:12.09.2018 for the construction of Anganwadi Centres for the year 2018-19.
- 6. The Government after careful examination have decided to accept the proposal of the Director of Rural Development and Panchayat Raj and accord sanction for construction of 1303 New Anganwadi Centres in convergence with Integrated Child Development Service Scheme of Social Welfare and Nutritious Meal Programme Department at a total cost of Rs.118.31 crore which includes Rs.65.15 crore under Mahatma Gandhi National Rural Employment Guarantee Scheme, Rs.26.06 crore under Integrated Child Development Service Scheme of Social Welfare and Nutritious Meal Programme Department and Rs.27.10 crore under Panchayat Union General Fund or Panchayat General Fund by adopting the guidelines issued in G.O.(Ms).No.125, Rural Development and Panchayat Raj (CGS.1) Department, dated:12.09.2018 subject to the condition that the financial sanction shall be approved after getting the release of Central share.
  - 7. Ensure three stage photography i.e. before, during and after work.
- 8. Government of India and State Government guidelines should be followed strictly.
  - 9. Utilization Certificate should be sent to Government of India as per instructions.
- 10. No duplication of works be ensured with Integrated Child Development Services Scheme (ICDS) and Multi-sectoral Development Programme (MSDP) schemes.
- 11. This order is issued with the concurrence of Finance Department vide its U.O.No.49956/RD/2019, dated:09.10.2019.
