ORDER:

The Director of Rural Development and Panchayat Raj in the letter second read above, has stated that the Government of India in their letter dated 31.05.2016 have indicated Rs.537.02 Crore as initial allocation to the State of Tamil Nadu for the execution of work under Swachh Bharat Mission(Gramin) during the financial year 2016-17. The Government of India in their sanction orders (three orders) dated 30.12.2016 have released a sum of Rs.134,25,47,000/- to the State Government

towards balance part of second installment of Grants-in-aid as Central Share under Swachh Bharat Mission(Gramin) for the year 2016-17 as detailed below:

2. The Government of India have already released a sum of Rs.402,76,41,000/to the State Government on 13.04.2016, 18.05.2016 and 14.10.2016 towards 1st and part of the 2nd installment of grants-in-aid as Central Share under Swachh Bharat The Government have sanctioned Mission(Gramin) for the year 2016-17. Rs.671,27,34,000/- (Central Share Rs.402,76,41,000/-(60%) and State Matching share Rs.268,50,93,000/-(40%) towards 1st and part of 2nd installment of Grants-in-aid under Swachh Bharat Mission(Gramin) for the year 2016-17 vide G.O.(Ms)No.54, Rural Development and Panchayat Raj(CGS-1) Department, dated 03.05.2016, G.O.(Ms) No.82, Rural Development and Panchayat Raj(CGS-1) Department, dated 06.07.2016 and G.O.(Ms)No.138, Rural Development and Panchayat Raj(CGS-1) Department, dated 18.11.2016. In the Revised Budget Estimate 2016-17, the Government have provided Rs.537,01,88,000/- under Swachh Bharat Mission(Gramin). Further, the Government in G.O.(Ms) No.138, Rural Development and Panchayat Raj Department(CGS-1) Department, dated 18.11.2016 have ordered that necessary additional provision of Rs.134,25,46,000/- will be provided in RE/FMA 2016-17. As per

the orders of Government, an amount of Rs.671,27,34,000/- was drawn and disbursed to the Districts for the implementation of Scheme as detailed below:

The Director of Rural Development and Panchayat Raj has also stated that, as per Government of India's Sanction Order dated 30.12.2016, the State shall ensure release/transfer of Central Share along with State Matching Share to the implementing agencies within 15 days of its receipt. As per the revised sharing pattern (60:40) under Swachh Bharat Mission(Gramin), as against the release of part of second installment of Central Share of Rs.134,25,47,000/- (60%) corresponding State Matching Share work out is Rs.89,50,31,000/- (40%).

4. The Director of Rural Development and Panchayat Raj has therefore requested the Government to authorize the Director of Rural Development and Panchayat Raj to draw the balance part of the second installment of Central Share of Rs.134,25,47,000/- and also sanction the corresponding State Matching Share of Rs.89,50,31,000/- under Swachh Bharat Mission(Gramin) for the year 2016-17 from the following Government head of account and disburse the same to the Districts:-

After careful examination, the Government accord sanction for release of a sum of Rs. 223,75,80,000/- (Rupees Two hundred and twenty three crore seventy five lakh and eighty thousand only) [Central share of Rs.134,25,47,000/- (60%) + State matching share Rs.89,50,33,000/- (40%)] towards balance part of the second installment of grants-in-aid under Swachh Bharat Mission(Gramin) for the year 2016-17.

7. Necessary additional amount of Rs.223,75,80,000/- will be provided in Final Modified Appropriation 2016-17. Pending Provision of such funds, the Director of Rural Development and Panchayat Raj is authorized to draw and disburse the amount sanctioned in para 5 above, to the districts. However, this expenditure shall be brought to the notice of Legislature by Specific inclusion in the Supplementary Estimate for 2016-17. The Director of Rural Development and Panchayat Raj is also requested to include the above expenditure while sending the proposal for Final Modified Appropriation/Supplementary Estimate 2016-17 and also send necessary draft explanatory note for inclusion in Supplementary Estimate 2016-17 to the Finance(RD/BGI) Department on appropriate time without fail.
