## **ORDER:-**

In the letter first read above, the Chief Executive Officer, Tamil Nadu Rural Transformation Project has stated that the Tamil Nadu Rural Transformation Project is implemented with an objective of promoting rural enterprises, access to finance for business plans and facilitating skills and job opportunities. The project is being implemented in 3994 villages of 120 non PVP (Pudhu Vaazhvu Project) blocks in 26 districts of the State at an estimate of Rs.918.20 crore (142.85 M US \$). The World Bank is providing a loan assistance of 100 M US \$ (70%) and the Government of Tamil Nadu bears 42.85 M US \$ (30%). Tamil Nadu Rural Transformation Project needed the total amount of Rs.228.88 Crore for this financial year 2021-22, after deducting the available amount of Rs.58.59 Crore (available for the committed expenditure as on 31.03.2021), the sum of Rs.170,29,89,000/- has been sought for from Government for the Financial Year 2021-22.

2. After careful examination of the proposal of the Chief Executive Officer, Tamil Nadu Rural Transformation Project, in the G.O second read above, the Government had sanctioned Rs.89,84,49,200/- (Rupees Eighty Nine Crore Eighty Four Lakhs Forty Nine Thousand and Two Hundred only) as first instalment for the year 2021-22 for implementing the above said project.

3. In the Budget Speech, the Hon'ble Minister for Finance has announced on the floor of Tamil Nadu Legislative Assembly on 13.08.2021 that Tamil Nadu Rural Transformation Project will be revamped with the funding of Rs.212.69 Crore for the financial year 2021-22.

4. In the letter third read above, Chief Executive Officer, Tamil Nadu Rural Transformation Project has therefore requested the Government to sanction the second

instalment amount of Rs.80,45,39,800/- (Rupees Eighty Crore Forty-five Lakhs Thirty-Nine Thousand and Eight Hundred only) for the financial year 2021-22 for implementing the project and to authorize the Director of Rural Development and Panchayat Raj, Chennai to draw and disburse the above amount to the Chief Executive Officer, Tamil Nadu Rural Transformation Project.

5. The Government after careful examination of the proposal of the Chief Executive Officer, Tamil Nadu Rural Transformation Project have decided to release a sum of Rs.80,45,39,500/- (Rupees Eighty Crore Forty-five Lakhs Thirty-Nine Thousand and Five Hundred only) as second instalment for the year 2021-22 for implementing the above said project.
