#### ORDER:

The Honourable Minister for Municipal Administration, Rural Development and Implementation of Special Programme has made the following announcement under Mahatma Gandhi National Rural Employment Guarantee Act on the floor of the Legislative Assembly on 16.03.2020

"விவசாயிகள் உற்பத்தி செய்கின்ற விளைபொருட்களை பாதுகாக்க போதிய சேமிப்பு வசதிகள் ஏற்படுத்தும் வகையில், 2020–21ஆம் நிதியாண்டில் ஊரகப்பகுதிகளில் 100 உணவு தானிய சேமிப்பு கிடங்குகள் தலா 14 இலட்சத்து 8 ஆயிரம் ரூபாய் மதிப்பீட்டில் மொத்தம் 14 கோடியே 8 இலட்சம் ரூபாய் மதிப்பீட்டில் கட்டப்படும்"

2. Based on the above announcement, the Director of Rural Development and Panchayat Raj has sent a proposal stating that the Revised Schedule I of the National Rural Employment Guarantee Act, 2005 Paragraph 4 (1) IV Category-D: (v) permits the construction of buildings for Gram Panchayats, Women Self Help Group Federations, Cyclone Shelters, Anganwadi Centres, Village Haats and Crematoria, Construction of play fields, Creating infra-structure for promotion of fisheries such as Fish Drying Yards, Storage Facilities, and promotion of fisheries in seasonal water bodies on public land. The construction of Food Grain Godown is a permitted activity as per Sl. No. 1 of Para 7.2.1 - "list of permissible works" under the **Annual Master Circular 2019-20** of Mahatma Gandhi National Rural Employment Guarantee Act. The construction of Food Grain Storage Building for community is a permissible activity as per Sl. No 5 of the list of restructuring permissible works under Mahatma Gandhi National Rural Employment Guarantee Act . Hence, it is proposed to construct 100 Food Grain Godowns at an unit cost of Rs.14.08 lakhs with a total cost of Rs.14.08 crore under Mahatma Gandhi National Rural Employment Guarantee Scheme during the year 2020-21. The above work has been proposed in the Labour Budget for the FY 2020-21 and in the minutes of Labour Budget meeting held on 13.03.2020, Ministry of Rural Development, Government of India has approved Labour Budget of 27 Crore persondays under Mahatma Gandhi National Rural Employment Guarantee Act to Tamil Nadu for the financial year 2020-21. The Government of India have notified the wage rate for the Financial Year 2020-21 as Rs.256/- per day in respect of Tamil Nadu. Accordingly, the wage rate for the year 2020-21 approved in G.O.Ms. No.82, RD&PR (CGS.1) Department, Dated: 30.03.2020 and Rural Schedule of Rates approved in G.O.Ms. No86, RD&PR (CGS.1) Department, Dated: 13.4.2020 shall be adopted. In case of any revision made in Rural Schedule of Rates in future, the same shall be adopted. The detailed guidelines issued vide G.O.(Ms).No.109, Rural Development and Panchayat Raj (CGS1) Department dated 07.08.2018 and G.O.(Ms) No.104, RD & PR (CGS.1) Department, Dated 31.07.2019 regarding the construction of Food Grain Godowns shall be adopted and referred for Planning, selection of work, Type Design, Non Negotiable items and Technical Specification without any change. In addition to the above guidelines, the following guidelines shall also be adopted.

### **Selection Criteria**

- Government poromboke land located in rural areas only shall be selected for the construction of food grain godown.
- Resolution shall be obtained in Grama Sabha for all the selected works and it shall be entered work wise in Register No.2 of Mahatma Gandhi NREGA of the village Panchayat concerned.

#### Non-Negotiable Items:

• Estimate creation, Administrative sanction and Technical sanction shall be done in SECURE software.

3. The Director of Rural Development and Panchayat Raj has further stated that the unit cost of Food Grain Godown based on the Model Estimate will be Rs.14.08 lakh. The Labour cost is borne 100% by the Government of India and the material cost is shared at the ratio of 75:25 by the Government of India and the State Government. The fund requirement and the central and state share for the construction of Food Grain Godown is given below:

The Director of Rural Development and Panchayat Raj has therefore requested the Government to accord sanction for the construction of 100 Food Grain Godowns at a total cost of Rs.14.08 crore under Mahatma Gandhi National Rural Employment Guarantee Scheme during the year 2020-21 and to adopt the guidelines issued vide G.O.(Ms) No.109, RD & PR (CGS.1) Department, Dated 07.08.2018 and G.O.(Ms) No.104, RD & PR (CGS.1) Department, Dated 31.07.2019 regarding the construction of Food Grain Godown for the year 2018-19 and 2019-20.

5. The Government after careful examination, have decided to accept the proposal of the Director of Rural Development and Panchayat Raj and accord Administrative Sanction for construction of 100 Food Grain Godowns at a total cost of Rs.14.08 crore under Mahatma Gandhi National Rural Employment Guarantee Act during the year 2020-21 in Rural areas and to adopt the guidelines issued vide G.O.(Ms) No.34, RD & PR(CGS.1) Department, Dated 04.03.2014 and G.O.(Ms) No.109, RD & PR(CGS.1) Department, Dated 07.08.2018 and G.O.(Ms) No.104, RD & PR (CGS.1) Department, Dated 31.07.2019 regarding the construction of Food Grain Godown, subject to the condition that the financial sanction shall be approved after getting the release of Central Share.

6. This order is issued with the concurrence of Finance Department vide its U.O.No.34299/RD/20 dated 09.10.2020.
