ORDER:

The Honourable Minister for Municipal Administration, Rural Development and Implementation of Special Programme has made the following announcement on the floor of the Legislative Assembly on 16.03.2020:

“ஊரகப்பகுதிகளில் உள்ள விவசாயிகள் மற்றும் கைவினைஞர்கள் தங்கள் உற்பத்தி பொருள்களை விற்பனை செய்யும் பொருட்டும் மற்றும் சுயஉதவிக்குழுக்களின் உற்பத்தி பொருட்களை சந்தைப்படுத்தும் வகையிலும், 2020-21 ஆம் நிதியாண்டில் 100 கிராம சந்தைகள் தலா 41 இலட்சத்து 3 ஆயிரம் ரூபாய் மதிப்பீட்டில் மொத்தம் 41 கோடியே 3 இலட்சம் ரூபாய் மதிப்பீட்டில் அமைக்கப்படும்”.

2. Based on the above announcement, the Director of Rural Development and Panchayat Raj has sent a proposal stating that the Rural Village haats are marketing centres constructed for the benefit of rural farmers, artisans and Self Help Groups. Rural Haats help in creation of better marketing facilities, enabling the rural poor to sell their products throughout the year, one stop shopping platform to the wholesalers, retailers/consumers by showcasing the range of local rural products, thereby improving socio-economic condition. The Para 7.7(b) of **Annual Master Circular 2019-20** of Mahatma Gandhi NREGA permits the construction/Upgradation of Village Haats in rural areas. The construction of Village Haats for community is a permissible activity as per Sl.No.252 of the list of restructuring permissible works under Mahatma Gandhi National Rural Employment Guarantee Scheme. Hence, it is proposed to construct 100 Nos. of Village Haats during the year 2020-21 at an estimated unit cost of Rs.41.03 lakhs and at a total cost of Rs.41.03 crore under Mahatma Gandhi National Rural Employment Guarantee Scheme. The above work

has been proposed in the Labour Budget for the Financial Year 2020-21 and the Ministry of Rural Development, Government of India has approved Labour Budget of 27 crore persondays under Mahatma Gandhi National Rural Employment Guarantee Scheme to Tamil Nadu for the financial year 2020-21. The Government of India have notified the wage rate for the Financial Year 2020-21 as Rs.256/- per day in respect of Tamil Nadu. Accordingly, the wage rate for the year 2020-21 approved in G.O.(Ms.) No.82, RD&PR (CGS.1) Department, Dated: 30.03.2020 and Rural Schedule of Rates approved in G.O.(Ms.) No.86, RD&PR (CGS.1) Department, Dated: 13.04.2020 shall be adopted. In case of any revision made in Rural Schedule of Rates in future, the same shall be adopted. The detailed guidelines issued vide G.O.(Ms.) No.123, Rural Development and Panchayat Raj (CGS1) Department dated 12.09.2018 regarding the construction of Village Haats shall be adopted and referred for Planning, selection of work, Type Design, Non Negotiable items and Technical Specification without any change. In addition to this, the following guidelines shall also be adopted.

Selection Criteria

- Resolution shall be obtained in the Grama Sabha for all the selected works and it shall be entered work wise in Register No.2 of Mahatma Gandhi NREGA of the village Panchayat concerned.

Non-Negotiable Items

- Estimate creation, Administrative sanction and Technical sanction shall be done in SECURE software.

3. The Director of Rural Development and Panchayat Raj has further stated that the unit cost of Village Haat based on Model Estimate will be Rs.41.03 lakh. The Labour cost is borne 100% by the Government of India and the material cost is shared at the ratio of 75:25 by the Government of India and the State Government. The fund requirement and the central and state share for the construction of Village Haats is given below:

The Director of Rural Development and Panchayat Raj has therefore requested the Government to accord sanction for the construction of 100 Village Haats at a total cost of Rs.41.03 crore under Mahatma Gandhi National Rural Employment Guarantee Scheme during the year 2020-21 and to adopt the guidelines issued vide G.O.(Ms.)No.123, RD & PR (CGS.1) Department, Dated

12.09.2018 for the construction of Village Haats for the year 2018-19 for the village haats to be constructed during 2020-2021.

5. The Government, after careful examination, have decided to accept the proposal of Director of Rural Development and Panchayat Raj and accord Administrative Sanction for the construction of 100 Village Haats at a total cost of Rs.41.03 crore under Mahatma Gandhi National Rural Employment Guarantee Scheme during the year 2020-21 by adopting the guidelines issued vide G.O.(Ms.) No.123, RD & PR (CGS.1) Department, Dated 12.09.2018 regarding the construction of Village Haats for the year 2018-19, subject to the condition that the Financial sanction shall be made only after receipt of Government of India share.

6. This order issues with the concurrence of Finance Department vide its U.O.No.39312/RD/20, dated: 03.11.2020.
