ORDER:

Government of India approved 11 clusters in three phases under Shyama Prasad Mukherji Rurban Mission(SPMRM) for the State of Tamil Nadu as indicated below :-

Phase I(2016-19)

2. As per Framework of Implementation (FOI) of Shyama Prasad Mukherji Rurban Mission (SPMRM), in order to support the Mission at State Level, an administrative cost of 2% of the total amount of Critical Gap Fund (CGF) has been provided for supporting State Project Management Unit (SPMU), District Project Management Unit (DPMU), Cluster Development and Management Unit (CDMU) and other support arrangements at the State. The administrative cost is shared in the ratio of 60:40. A sum of Rs.6.60 Crore is eligible as 2% administrative cost under Shyama Prasad Mukherji Rurban Mission (SPMRM) for the above 11 clusters, out of which the Central share is Rs.3.96 Crore and the State share is Rs.2.64 Crore.

3. Government of India released a sum of Rs.1.75 Crore towards preparation of Integrated Cluster Action Plan (ICAP) for the five clusters approved in Phase I (2016-19) under Shyama Prasad Mukherji Rurban Mission (SPMRM). In the Government Order first read above, a sum of Rs.1.05 Crore has been released towards preparation of Integrated Cluster Action Plan (ICAP) for the three clusters approved in Phase II (2017-2020) as Central share and in the Government Order second read above, a sum of Rs.1.05 Crore has been released towards preparation of Integrated Cluster Action Plan (ICAP) for the three clusters approved in Phase III (2018-2021) as Central share. Thus, till now Government of India released a sum of Rs.3.85 Crore for 11 clusters towards preparation of Integrated Cluster Action Plan (ICAP) under Shyama Prasad Mukherji Rurban Mission (SPMRM).

4. In the letter third read above, the Director (SPMRM), Ministry of Rural Development, Government of India, has requested to release the corresponding State share of administrative fund so that the Mission activities may be expedited. Accordingly, the Director of Rural Development and Panchayat Raj in his letter fourth read above has requested the Government to issue orders to release a sum of Rs.2,56,00,000/- being State share towards 2% administrative cost and to maintain the funds in the account of State Nodal Agency under Shyama Prasad Mukherji Rurban Mission (SPMRM).

5. The Government after careful examination have decided to accept the proposal of the Director of Rural Development and Panchayat Raj and accordingly sanction and release a sum of Rs.2,56,00,000/- (Rupees Two Crore Fifty Six Lakh only) being State share towards 2% administrative cost under Shyama Prasad Mukherji Rurban Mission (SPMRM).

6. The expenditure sanctioned in paragraph 5 shall be debited to the following Head of Account:
