ORDER:

In the Government Order first read above, orders were issued for the implementation of Namakku Naame Thittam for the year 2021-2022 along with the detailed Guidelines.

2. The Hon'ble Chief Minister of Tamil Nadu has made the following Announcement on the Floor of the Tamil Nadu Legislative Assembly on 7.1.2022 during the debate on the Governor's Address:-

"நமக்கு நாமே திட்டத்தின் கீழ் உள்ள மூன்றில் ஒரு பங்கு ்க்களுடைய பங்கு என்பதை பட்டியலின மற்றும் பழங்குடியின மக்களுக்கு ஐந்தில் ஒரு பங்கு என விதிகள் தளர்த்தப்படும்".

3. As per the above Announcement of the Hon'ble Chief Minister of Tamil Nadu, the Director of Rural Development and Panchayat Raj in the letter 3rd read above, has sent a proposal to Government stating that the Namakku Naame Thittam (NNT) is a participatory demand driven scheme announced by Dr. Kalaignar M.Karunanidhi, Hon'ble former Chief Minister of Tamil Nadu during 1997-98 Budget Speech to promote and strengthen the Self Help and Self-reliant attitude of the community and Guidelines for the implementation of this scheme were issued in G.O.(Ms.) No.112, RD(IRD-1) Department dated: 01.06.1998. The Scheme involves the community directly in the developmental process from planning stage through resource mobilization, execution to the maintenance stage. State

Government's financial support supplements the efforts of the community, besides technical support. This Scheme gives enough scope for covering all the felt needs of the public.

- 4. He has further stated that as per para 2 of the existing guidelines the minimum public contribution for any of the identified works should be atleast one-third of the estimate amount for the work and as per para 7(iii)(a), in execution of works also it is instructed to facilitate larger participation of the people in this scheme, if the public or contributors opt to execute the work themselves or through their agency and if the public contribution is 50% or more of the estimate of the value of the work, willingness should be given by them in writing while applying for the work under Namakku Naame Thittam. The District Collector will examine the request and permit the contributors or the agency to execute the work without tender, after assessing the contributor's technical and financial capability to execute the project.
- 5. He has further stated that the Government is focussing on inclusive socio-economic development of the State. In this regard, basic analysis has been done to check the inclusive development and community contribution from all sectors of the society. In this regard, the details of number of works taken up in SC/ST Habitations in the Districts have been furnished by the Districts. On analysing the details of the works taken up in SC/ST Habitations, it was found that number of works taken up in SC/ST Habitations is only 8% of the total works taken up, which is comparatively very low in Districts. Hence, the minimum Public contribution may be revised to one-fifth of the estimate amount, instead of the existing 1/3rd of the estimate amount for the works taken up in SC/ST Habitations.
- 6. He has also stated that in the execution of works, if the works are taken up in SC/ST Habitations, and if the contributors opt to execute the works themselves or through their agency, the public contribution shall be revised to 1/3rd or more of the estimate of the value of the work instead of the existing 50% or more of the estimate of the value of the work, willingness should be given by them in writing while applying for the work under Namakku Naame Thittam (Rural). The District Collectors will examine the request and permit the contributors or the agency to execute the work without tender, after assessing the contributor's technical and financial capability to execute the project.
- 7. The Director of Rural Development and Panchayat Raj has therefore requested the Government for amending the Guidelines both in English and Tamil of Namakku Naame Thittam for the year 2021-2022 issued in G.O.(Ms) No.147, Rural Development and Panchayat Raj (SGS-1) Department, dated 14.12.2021 under paras 2 and 7(iii)(a).
- 8. The Government have carefully examined the proposal of the Director of Rural Development and Panchayat Raj in para 7 above in detail and decided that paras 2 and 7(iii)(a) of the Guidelines annexed to the G.O.(Ms) No.147, Rural Development and Panchayat Raj (SGS-1) Department, dated 14.12.2021 shall be substituted with the following Amendments in English and Tamil and order accordingly.

AMENDMENT IN ENGLISH

2. Public participation

The minimum public contribution for any of the identified works should be atleast one-third of the estimate amount for the work. In respect of SC/ST habitations, the minimum Public Contribution should be 1/5th of the estimate amount of the work.

(iii) To facilitate larger participation of the people in this scheme, if the public or contributors opt to execute the work themselves or through their agency and if the public contribution is 50% or more of the estimate of the value of the work, and in respect of SC/ST habitations, if the Public Contribution is 1/3rd or more of the estimate of the value of the work, willingness should be given by them in writing while applying for the work under Namakku Naame Thittam. The District Collector will examine the request and permit the contributors or the agency to execute the work without tender, after assessing the contributor's technical and financial capability to execute the project.

பொது மக்கள் இத்திட்டத்தில் பெரிய அளவில் பங்கேற்க (iii) மக்களோ அல்லது பணிக்கான பங்களிப்பை ஏதுவாக, பொது அளித்தவர்களோ, மேற்கண்ட பணியை **தாங்களாகவோ** அல்லது அவர்களின் முகவர்கள் மூலமாகவோ செய்திட விரும்பினால், நமக்கு நாமே திட்டத்தின் கீழ் விண்ணப்பம் செய்யும் போது எழுத்து பூர்வமாக தெரிவிக்க வேண்டும். மாவட்ட ஆட்சித்தலைவர் இந்த கோரிக்கையை ஆய்வு செய்து, அப்பணியின் மதிப்பீட்டில் பொது மக்களின் பங்களிப்பு, மதிப்பீட்டில் 50 சதவீதம் அல்லது அதற்கு மேல் இருந்தால், மேலும் பட்டியல் இனத்தவர் (SC)/பழங்குடியினர் (ST) குடியிருப்புகளை பொறுத்தவரையில் பொது மக்களின் பங்களிப்பு, மதிப்பீட்டில் மூன்றில் ஒரு பங்கு அல்லது அதற்கு மேலும் இருந்தால், பங்களிப்போரின் தொழில்நுட்ப மற்றும் நிதித் திறனை மாவட்ட ஆட்சித் தலைவர் மதிப்பீடு செய்து, ஒப்பந்தப்புள்ளியின்றி பங்களித்தவரையோ அல்லது அவரின் முகவரையோ, அப்பணியை செயல்படுத்த அனுமதி வழங்கலாம்.
