### ORDER:

In the letter first read above, Ministry of Rural Development, Government of India had communicated the physical target of 1,30,214 houses for the year 2017-18 under Pradhan Mantri Awaas Yojana(Gramin).

2. In the letter second read above the Government of India have sanctioned a sum of Rs.487.52 crore towards the 1st installment of Central share including 4% administrative cost under Pradhan Mantri Awaas Yojana(Gramin) 2017-18.

3. In the Government Order third read above, the Government have accorded sanction for the release of Rs.812,53,53,440 as 1st installment of Central and State share under Pradhan Mantri Awaas Yojana(Gramin) for the year 2017-18.

4. In the Government Order fourth and fifth read above, Government have accorded sanction for the release of Rs.325,53,50,000/- towards the 1<sup>st</sup> installment of State Additional Fund for RCC Roofing Cost.

5. In the letter sixth read above, the Director of Rural Development and Panchayat Raj has stated that the necessary proposal has been sent again to Ministry of Rural Development, Government of India to release the 2<sup>nd</sup> installment of Central share including 4% Administrative cost to the tune of Rs.487.52 crore under PMAY (G) 2017-18 and the funds will be released shortly by the Government of India and State Additional fund of RCC Roofing cost is being released to the beneficiaries for the purchase of materials like Cement, Steel, Brick, Sand, Doors and Windows etc., so that it will be helpful to the poor beneficiaries to be brought up their houses to the next stage.

6. The Director of Rural Development and Panchayat Raj has therefore requested the Government to accord sanction for a sum of Rs.325,53,50,000/- (Rupees Three hundred and twenty five crore fifty three lakhs fifty thousand only) as 2<sup>nd</sup> Installment of State Additional Fund for RCC Roofing cost under Pradhan Mantri Awaas Yojana(Gramin) for the year 2017-18, so that payment to all beneficiaries can be made based on the progress of the houses.

7. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction for a sum of Rs. 325,53,50,000/- (Rupees Three hundred and Twenty five Crore Fifty Three Lakh and Fifty thousand only) towards 2<sup>nd</sup> installment of State Additional Fund for RCC Roofing Cost under PMAY(G) for the year 2017-18.

8. The expenditure sanctioned in para 7 above shall be debited under the following heads of account:-
