### **ORDER:**

In the letter second read above, The Managing Director, Tamil Nadu Corporation for Development of Women Limited has stated that Government of India have sanctioned a sum of Rs.95,37,00,000/- being the 60% share of 1<sup>st</sup> tranche of 2<sup>nd</sup> instalment of fund for the year 2021-22 under National Rural Livelihood Mission(NRLM) and instructed the State Government to release the fund along with the corresponding 40% State share immediately to Tamil Nadu State Rural Livelihoods Mission (TNSRLM).

2. The Managing Director, Tamil Nadu Corporation for Development of Women Limited has therefore requested the Government to sanction and release the total amount of Rs.158,95,00,000/- (Rupees One Hundred and fifty eight Crore ninety five lakh only) as 60% of Central share Rs.95,37,00,000/- and 40% of State share Rs.63,58,00,000/- for National Rural Livelihoods Mission for the year 2021-22.
