From the Director of Rural Development and Panchayat Raj, Letter Roc.No.19961/2019/ MGNREGS-II-2, dated 14.09.2020.

ORDER:

The Director of Rural Development and Panchayat Raj, in the letter read above, has stated that the Revised Schedule I of the National Rural Employment Guarantee Act, 2005 Paragraph 4 (1) IV Category-D: (v) permits the construction of buildings for Gram Panchayats, Women Self-help groups, Federations, Cyclone shelters, Anganwadi Centres, Village haats and crematoria at the Village or Block Level. The construction of Anganwadi Centres is a permissible activity as per Sl. No 1 of the list of permissible works under Annual Master Circular 2020-21 of Mahatma Gandhi National Rural Employment Guarantee Act. The Government of India in its letter dated 29.07.2020 has given the approval for construction of 1000 Anganwadi Centres during the year 2020-21 in convergence with Mahatma Gandhi National Rural Employment Guarantee Scheme at Rs.2 Lakh per Anganwadi Centres as Integrated Child Development Services Scheme share (Gol share Rs.1.00 Lakh & State Share Rs.1.00 Lakh) in Annual Programme Implementation Plan 2020-21. It has also been informed therein that Government of India share of Rs.1.00 Lakh per Anganwadi Centre will be released only after completion of construction of Anganwadi Centres. In this regard, the Director cum Mission Director, Integrated Child Development Services Scheme Department has requested to send the concurrence for the above line for the construction of 1000 Anganwadi Centres during the year 2020-21 in convergence with Integrated Child Development Services Scheme Department.

2. The Director of Rural Development and Panchayat Raj has further stated that, it is proposed to construct 1000 Anganwadi Centre Buildings at an unit cost of

Rs.10.19 Lakhs (Rs.5.00 Lakhs under Mahatma Gandhi National Rural Employment Guarantee Act, Rs.2.00 Lakhs under Integrated Child Development Services Scheme from Social Welfare Department and Rs.3.19 Lakhs from Panchayat Union General Fund or Panchayat General Fund) under Mahatma Gandhi National Rural Employment Guarantee Scheme in convergence with Integrated Child Development Services Scheme (ICDS) and Panchayat Union General Fund or Panchayat General Fund at a total cost of Rs.101.90 Crores to provide nutrition to children from two to five years and supplementary nutrition to pregnant and lactating mothers pre-school education, health and to inculcate the habit of personal hygiene in children, adolescents, pregnant and nursing mothers.

3. The Director of Rural Development and Panchayat Raj has also stated that the Government of India have notified the wage rate under Mahatma Gandhi National Rural Employment Guarantee Scheme for the Financial Year 2020-21 as Rs.256/- per day in respect of Tamil Nadu. Accordingly, the wage rate for the year 2020-21 approved in G.O.Ms.No.82, Rural Development and Panchayat Raj (CGS.1) Department, Dated: 30.03.2020 and Rural Schedule of Rates approved in G.O.Ms. No.86, Rural Development and Panchayat Raj (CGS.1) Department, Dated: 13.04.2020 shall be adopted. In case of any revision made in Rural Schedule of Rates in future, the same shall be adopted.

4. The Director of Rural Development and Panchayat Raj has further stated that the detailed guidelines issued for the construction of Anganwadi Centres vide G.O.(Ms).No.149, Rural Development and Panchayat Raj (CGS1) Department dated 11.10.2019 shall be adopted and referred for Planning, selection of work, Non Negotiable items and Technical Specification without any change. In addition to the above guidelines, the following guidelines shall also be adopted;

Selection Criteria:

- The old Anganwadi Centres which are in dilapidated condition and which are more than 30 years old shall be taken up for construction.
- The old Anganwadi Centres which are in dilapidated condition and which are 20-30 years old shall be taken up for construction after the approval of committee comprising of District Collector/Chairman, Project Director, Executive Engineer(RD) and Assistant Director (Panchayat).
- Resolution shall be obtained in Grama Sabha for all the selected works and it shall be entered work wise in Register No.2 of Mahatma Gandhi National Rural Employment Guarantee Act of the village Panchayat concerned.

Non-Negotiable Items:

- Estimate creation, Administrative sanction and Technical sanction shall be done in SECURE software.

5. The Director of Rural Development and Panchayat Raj has further stated that the unit cost of Anganwadi Centre will be Rs.10.19 Lakhs (Rs.5.00 Lakhs under Mahatma Gandhi National Rural Employment Guarantee Scheme, Rs.2.00 Lakhs under ICDS from Social Welfare Department and Rs.3.19 Lakhs from Panchayat Union General Fund or Panchayat General Fund). The Labour cost is borne 100%

by the Government of India and the material cost is shared at the ratio of 75:25 by the Government of India and the State Government. The fund requirement and the Central and State share for the construction of Anganwadi Centre is given below:

Therefore, the Director of Rural Development and Panchayat Raj has requested the sanction of the Government for the construction of 1000 New Anganwadi Centres in convergence with Integrated Child Development Services Scheme (ICDS) at a total cost of Rs.101.90 Crores which includes Rs.50 Crores under MGNREGS, Rs.20 Crores under Integrated Child Development Services Scheme (ICDS) and Rs.31.90 Crores under Panchayat Union General Fund or Panchayat General Fund during the year 2020-21 by adopting the guidelines issued for the construction of Anganwadi Centres vide G.O.(Ms) No.149, Rural Development and Panchayat Raj (CGS.1) Department, Dated 11.10.2019 for the Financial year 2019-2020.

7. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj accord Administrative sanction for construction of 1000 New Anganwadi Centres in convergence with Integrated Child Development Services Scheme (ICDS) at a total cost of Rs.101.90 Crores which includes Rs.50 Crores under MGNREGS, Rs.20 Crores under Integrated Child Development Services Scheme (ICDS) and Rs.31.90 Crores under Panchayat Union General Fund or Panchayat General Fund during the year 2020-21 by adopting the guidelines issued for the construction of Anganwadi Centres vide G.O.(Ms) No.149, Rural Development and Panchayat Raj (CGS.1) Department, Dated 11.10.2019 for the Financial year 2019-2020, Subject to the condition that the Financial Sanction shall be approved only after getting the Central Share.

8. The Commissioner of Rural Development and Panchayat Raj is directed to ensure the compliance of the following:-

- (i) Three stage photography i.e., before, during and after work shall be ensured.

- (ii) Government of India and State Government guidelines should be followed strictly.
- (iii) Utilization Certificate should be sent to Government of India as per instructions.
- (iv) No duplication of works shall be ensured with Integrated Child Development Services Scheme (ICDS) and Multi-Sectoral Development Programme (MSDP) schemes.
