ORDER:

In the Government Order first read above, the Government have issued orders for release of Rs.850,68,75,833/- as 1st installment of 1st Tranche of Central Assistance for Material and Administrative Component along with the proportionate State Share for Material Component for implementation of the Mahatma Gandhi National Rural Employment Guarantee Scheme during 2020-21. Subsequently, in the Government Orders second, third, fourth and fifth read above, the Government have issued orders for release of Rs.249,16,66,667/-, Rs.208,47,04,667/-, Rs.191,66,66,666/- and Rs.218,02,12,167/- respectively towards Material and Administrative Component along with proportionate State Share for Material

Component as 2nd, 3rd, 4th, and 5th installments of 1st Tranche of Central Assistance for implementation of the Mahatma Gandhi National Rural Employment Guarantee Scheme for the Financial Year 2020-21.

2. The Director of Rural Development and Panchayat Raj in his letter 7th read above has stated that the Government of India have now sanctioned a sum of Rs.94,60,14,000/- towards Material component and Admin component as 6th installment of 1st Tranche of Central Assistance for implementation of the MGNREGA for the Financial Year 2020-21 on condition that the State Government must transfer these funds along with the State share to the State Employment Guarantee Fund for programme implementation within a maximum period of 15 days from the receipt of Central funds in the State Treasury. The expenditure per person-day generation of wage employment shall have wage and material costs in the proportion of 60:40. The cost of wages is 100% borne by Government of India and as per Rule 22(1)(b) and (2)(b) of the NREGA Act 2005, the expenditure on material component including wages of skilled and semi-skilled labour will be shared between Centre and State Government in the ratio of 75:25. The administrative cost is 100% borne by Government of India. Hence, considering the above, Government of India release amount as 30% Government of India share towards Material Component including 6% Administrative Cost, out of the amount of Rs.94,60,14,000/-, Rs.15,76,69,000/- is arrived as 6% for Administrative Component and Rs.78,83,45,000/- towards 30% Material component. Taking into account of the above release of material component as 75% share of Government of India, the State has to bear the balance 25% of the cost of the material component which amounts to Rs.26,27,81,667/-.

3. The Director of Rural Development and Panchayat Raj has therefore requested orders of Government to sanction a sum of Rs.78,83,45,000/- towards Material component as 6th installment of 1st tranche of Central Assistance for the year 2020-21 along with the proportionate State Share of Rs.26,27,81,667/- and Rs.15,76,69,000/- towards Admin cost, totalling Rs.120,87,95,667/- (Rupees One Hundred and Twenty Crore Eighty Seven Lakh Ninety Five Thousand Six Hundred and Sixty Seven only) under MGNREGA for the year 2020-21 and requested to permit him to draw and transfer the amount to the State Employment Guarantee Fund of Tamil Nadu.

4. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction for a sum of Rs.78,83,45,000/- (Rupees Seventy Eight Crore Eighty Three Lakh and Forty Five Thousand only) towards Material component as 6th installment of 1st tranche of Central Assistance for the year 2020-21 along with the proportionate State Share of Rs.26,27,81,667/- (Rupees Twenty Six Crore Twenty Seven Lakh Eighty One Thousand Six Hundred and Sixty Seven only) and Rs.15,76,69,000/- (Rupees Fifteen Crore Seventy Six Lakh and Sixty Nine Thousand only) towards Admin cost, totalling to Rs.120,87,95,667/- (Rupees One Hundred and Twenty Crore Eighty Seven Lakh Ninety Five Thousand Six Hundred and Sixty Seven only) under MGNREGS for the year 2020-21.

5. The expenditure sanctioned in para 4 above shall be debited to the following heads of account:

6. Necessary additional funds of Rs.40,64,16,000/- will be provided in FMA 2020-2021. However, this expenditure shall be brought to the notice of Legislature by specific inclusion in the Supplementary Estimates 2020-2021. Pending provision of such funds, the Commissioner, Rural Development and Panchayat Raj Department is authorized to draw and transfer the amount sanctioned in paragraph '4' above. He is also directed to include this item of expenditure while sending the budget proposal for FMA 2020-2021 and also send necessary draft explanatory note for inclusion of this expenditure in the Supplementary Estimate 2020-2021 to Government in Finance (RD&PR/BG-1) Department at the appropriate time without fail.

7. The Commissioner of Rural Development and Panchayat Raj is authorized to draw and transfer the amount sanctioned in para 4 above to the State Employment Guarantee Fund Account of Tamil Nadu.

8. The Guidelines of Government of India shall be strictly followed. Social Audit shall also be ensured as per the Guidelines and Utilization Certificate shall be sent to Government of India as per norms with a copy marked to the Government.
