

ABSTRACT

Pradhan Mantri Awaas Yojana (Gramin) – Sanction for release of Rs.1217.1663 crore for SC & Other Category under PMAY(G) - Central Share of Rs.730.2998 crore released by Government of India excluding Admin Cost as 1st Tranche of 1st Instalment during the year 2021-22 for Pradhan Mantri Awaas Yojana (Gramin) 2018-19, 2019-20 and 2021-22 and also release of corresponding State matching Share of Rs.486.8665 crore – Orders – Issued.

ORDER:

The Director of Rural Development and Panchayat Raj in the letter 9th read above has stated that the Ministry of Rural Development, Government of India has earmarked

- 21,000 houses for the year 2018-19 under Pradhan Mantri Awaas Yojana (Gramin) and the same has been allotted to 35 Districts except Kanniyakumari and the Nilgiris Districts.
- 2) The Director of Rural Development and Panchayat Raj has stated that, in the letter 2nd read above, Government of India have sanctioned a sum of Rs.78.624 crore towards the 1st instalment of Central Share including 4% Admin cost under Pradhan Mantri Awaas Yojana (Gramin) 2018-19 and amount for the same has been credited to the SNA of Pradhan Mantri Awaas Yojana (Gramin). Accordingly, the Government of Tamil Nadu in the Government order 3rd read above, have accorded sanction for the release of State Share of Rs.52.416 crore including 4% of Admin Cost under Pradhan Mantri Awaas Yojana (Gramin) for 2018-19 and the same has been drawn and deposited in the SNA for transfer of funds to the beneficiaries through PFMS.
- 3) The Director of Rural Development and Panchayat Raj has further stated that the Ministry of Rural Development, Government of India was requested to sanction the 2nd instalment of Rs.78.624 crore including 4% Admin Cost of Central Share for the year 2018-19 under Pradhan Mantri Awaas Yojana (Gramin). The Ministry of Rural Development, Government of India, in the letter 6th read above, have released the 1st tranche of 2nd instalment of Central Share of Rs.37.80 crore by excluding 4% Admin cost for the year 2018-19.
- 4) Accordingly, In the Government Order 7th read above, the Government of Tamil Nadu has accorded sanction for Rs.63 crore which is inclusive of Central Share of Rs.37.80 crore and the corresponding State matching Share of Rs.25.20 crore towards 1st Tranche of 2nd instalment for the year 2018-19. The Central and State share has been drawn and credited to State Nodal Account for transfer of funds to the beneficiaries through PFMS.
- 5) The Director of Rural Development and Panchayat Raj has also stated that the Ministry of Rural Development, Government of India have released a sum of Rs.113.40 crore (excluding Admin fund) against the entitlement of Rs.151.20 crore (excluding Admin fund) for Pradhan Mantri Awaas Yojana (Gramin) 2018-19. As such, the Ministry of Rural Development, Government of India have released a sum of Rs.3.024 crore towards Admin cost against the entitlement of Rs.6.048 crore for Pradhan Mantri Awaas Yojana (Gramin) 2018-19.

- 6) In the letter 1st read above, the Ministry of Rural Development, Government of India, have communicated the physical target of 2,00,000 houses for the year 2019-20 under Pradhan Mantri Awaas Yojana (Gramin) and the same has been allocated to all Districts. Further, in Letter No.G-20011/01/2021-RH (A/C), dated 25.05.2021, Ministry of Rural Development, Government of India have allocated 2,89,887 houses for Tamil Nadu from the finalized "Awaas+" list of Pradhan Mantri Awaas Yojana (Gramin) for the financial year 2021-22.
- 7) Since, the programme fund released as 1st Tranche of 2nd instalment for the year 2018-19 has been fully utilized, the Ministry of Rural Development, Government of India has been requested to release the 2nd Tranche of 2nd instalment for the year 2018-19 and funds against target of 2,00,000 houses for 2019-20 and 2,89,887 houses for 2021-22 for the State of Tamil Nadu vide Director of Rural Development and Panchayat Raj letter dated 04.02.2022 and 22.02.2022.
- 8) In the letter 8th read above, the Ministry of Rural Development, Government of India have released a sum of Rs.730.2998 Crore under Schedule Caste and Others category towards programme fund excluding admin cost as 1st Tranche of 1st instalment of Central Assistance for the year 2021-22 as detailed below:

- 9) The Director of Rural Development and Panchayat Raj has stated that the release of Central Share for the Scheduled Tribe category is pending with Ministry of Rural Development, Government of India and the proposal for the same will be sent to the Government separately on receipt of funds from the Ministry of Rural Development, Government of India.
- 10) The Director of Rural Development and Panchayat Raj has stated that further, in the para 4 & 5 of the order issued in letter 8th read above, the Ministry of Rural Development, Government of India has stated as:
 - i) It is reiterated that while allocating targets to Districts, State should follow the formula prescribed by the Ministry. It is clarified that earmarked targets for SC, ST and Minority cannot be diverted to general category. Only SC and ST targets can be interchanged if there are sufficient justifications.
 - State Government should transfer these funds from Consolidated Fund of the State to the bank account of the State implementing agency dedicated to PMAY(G) within 3 days of receipt from the Central Government and in the event of failure on this account, the States will be liable to pay interest @12% per annum for the period of delay. The State share should also be released within 15 days from the date of release of Central share. In case of shortfall in State share, corresponding amount of central share will be deducted from the 2nd instalment. The factum of release of these funds must be registered in the Public Financial Management System (PFMS). The State Government is also requested to invariably endorse the copies of the release orders to the Central Government.
- 11) Based on the release of the Central Share of Rs.730.2998 Crore, the Director of Rural Development and Panchayat Raj has requested the Government in Rural Development and Panchayat Raj Department to release the corresponding State matching share amount of Rs.486.8665 crore as detailed below:

- 12) Therefore, the Director of Rural Development and Panchayat Raj has requested the Government to:
 - A. Accord sanction of fund for Scheduled Caste and Others category for Rs.1217,16,63,333/- which includes Central and State share and to release the Central Share (60%) of Rs.730,29,98,000/- and the corresponding State matching Share (40%) of Rs.486,86,65,333/- towards 1st tranche of 1st instalment (one fourth of the balance amount entitled for the year 2018-19 and one fourth of funds against target of 2,00,000 houses for 2019-20 and 2,89,820 houses for 2021-22) excluding Admin fund for Tamil Nadu 2021-22 and,
 - B. To issue necessary orders to recoup a sum of Rs.335 crore from SNA to the Additional RCC Roofing cost Account of State Government that was transferred and utilized as State matching share for the reasons as detailed below:
 - (i) The Government have sanctioned Rs.1805.48 crore from the State Fund for completion of 2,57,925 pending houses at the rate of Rs.70,000/- per house as Additional Roofing Grant vide G.O.(Ms). No.218, Rural Development and Panchayat Raj Department, dated:22.12.2020. Accordingly the same has been drawn vide DRD Proc. No.59258/2020/RHS 2-1, dated:22.01.2021 & 19.03.2021 respectively.
 - (ii) Due to non-receipt of Central share from Ministry of Rural Development, Government of India and paucity of funds in SNA and in order to avoid the delay in making payment to the beneficiaries as per the stage of the houses, a sum of Rs.335 crore has been transferred from Additional Roofing Grant Account to SNA account in anticipation of the release of fund from Government.
- 13) After careful examination, the Government have decided to accept the proposal of the Director of Rural Development and Panchayat Raj at para-12 above and issue orders on the following:-
 - (a) Sanction is accorded for the release of Rs.1217,16,63,333/- (Rupees One Thousand Two Hundred and Seventeen Crore Sixteen Lakh Sixty Three Thousand Three Hundred and Thirty Three only) under PMAY(G) towards Scheduled Caste and Others category which includes Central and State share towards 1st tranche of 1st Instalment (one fourth of the balance amount entitled for the year 2018-19 and one fourth of funds against target of 2,00,000 houses for 2019-20 and 2,89,820 houses for 2021-22) excluding Admin fund for Tamil Nadu 2021-22 and,
 - (b) The Director of Rural Development and Panchayat Raj is authorized to recoup the amount of Rs.335 crore to Additional RCC Roofing cost account of Pradhan Mantri Awaas Yojana (Gramin), already transferred to SNA and utilized as State matching share.
