ORDER:

In the Government Order first read above, Government have accorded Administrative Sanction for 769 road works and 25 bridge works under PMGSY-II(2017-18) at the cost of Rs.1244.35 Crore and maintenance cost for Rs.98.16 Crore; out of which Ministry of Rural Development Share is Rs.704.02 Crore and State Share is Rs.540.33 Crore.

2. The Director of Rural Development and Panchayat Raj has stated that as per the revised sharing pattern under Pradhan Mantri Gram Sadak Yojana(PMGSY) communicated by Ministry of Rural Development, Government of India, the funding by Government of India and State for 2018-19 for PMGSY has been issued in Ministry of Rural Development Letter No.P-17017/4/2018-RC, dated 09.04.2018 at 60:40 ratio. According to the communication, the Central Share for 2018-19 is Rs.600 Crore and State Share is Rs.400 Crore.

3. Based on the allotment, Ministry of Rural Development has released 1st installment of Rs.293.625 Crore; out of which Rs.57.4461 Crore is the balance Phase X(2016-17) works and Rs.236.1789 Crore pertains to PMGSY-II(2017-18) works as Central assistance for the year 2018-19 and the same was released by Government in G.O.(Ms) No.113, Rural Development and Panchayat Raj(CG.S.2) Department, dated 24.08.2018. In the G.O.(Ms) No.145, Rural Development and Panchayat Raj(CG.S.2) Department, dated 03.10.2018, the State Government has released Rs.195.75 Crore as State matching Share to the extent of Central release of Rs.293.625 Crore during 2018-19; out of which Rs.38.2974 Crore is the balance Phase X(2016-17) works and Rs.157.4526 Crore is for the PMGSY-II(2017-18) works.

4. The Director of Rural Development and Panchayat Raj has stated that Ministry of Rural Development has released 2nd installment of Rs.293.375 Crore towards PMGSY-II(2017-18) works for the year 2018-19, which has been released in G.O.(Ms) No.32, Rural Development and Panchayat Raj(CGS.2) Department, dated 28.02.2019. The State matching Share to that extent is Rs.195.58 Crore.

5. The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue necessary orders on the following:

- (i) To release a sum of Rs.195.58 Crore (Rupees One hundred and ninety five crore fifty eight lakh only) as State matching Share to the extent of Central release of Rs.293.375 Crore towards 2nd installment of Programme Fund for PMGSY-II(2017-18) works for the year 2018-19 in the following head of account :

4515 - 00 - Capital outlay on Other Rural Development Programmes - 103 - Rural Development - Schemes shared between State and Centre - UB - Road/Bridge works under PMGSY-II - 16 Major works.

- (ii) To authorise him to draw the sanctioned amount from Pay and Accounts Office(South), Chennai-35 and to transfer the same to Tamil Nadu Rural Housing and Infrastructure Development Corporation account.

6. The Government, after careful examination, have decided to accept the proposal of Director of Rural Development and Panchayat Raj and accord sanction a sum of Rs.195.58 Crore (Rupees One hundred and ninety five crore fifty eight lakh only) as State matching Share to the extent of Central release of Rs.293.375 Crore towards 2nd installment of Programme Fund for PMGSY-II(2017-18) works for the year 2018-19.

7. The expenditure of Rs.195.58 Crore for PMGSY-II(2017-18) for the year 2018-19 shall be debited under the following head of account:-

4515 - 00 - Capital outlay on Other Rural Development Programmes - 103 - Rural Development - Schemes shared between State and Centre - UB - Road/Bridge works under PMGSY-II - 16 Major works.

8. Necessary funds have already been provided in RE 2018-19. The Director of Rural Development and Panchayat Raj is authorized to draw and disburse the amount sanctioned in para 6 above to Tamil Nadu Rural Housing and Infrastructure Development Corporation account.
