ORDER:

In the Government Order first read above, orders were issued according Adminstrative Sanction for a sum of Rs.705 Crore allocating fund of Rs.3 Crore per Constituency along with detailed Guidelines for the implementation of Member of Legislative Assembly Constituency Development Scheme (MLACDS) for the year 2021-2022 and sanction was accorded for a sum of Rs.352.50 Crore being 50% of Fund out of Budget Allocation of Rs. 705 Crore inclusive of nominated MLA for the implementation of Member of Legislative Assembly Constituency Development Scheme for the year 2021-2022.

- his letter second read above, the Director of Rural Development and Panchayat Raj has stated that as per the Government order read above, Rs.351 Crore (excluding nominated MLA) has been released to all District Collectors (except Chennai) and the Commissioner of Greater Chennai Corporation vide his Proceedings dated 13.12.2021. The Director of Rural Development and Panchayat Raj has also stated that as we are already in the last quarter of this financial year 2021-2022 and also for ensuring speedy implementation of this scheme in all the Assembly Constituencies, the balance 50% of the Hence, the Director of Rural Development and MLACDS fund has to be released. Panchayat Raj has requested the Government to issue necessary orders for the release of balance 50% of the funds and it may be debitable to the respective head of accounts from the Budget Allocation for the year 2021-2022 under MLACDS.
- 3. The Government have carefully examined the proposal of the Director of Rural Development and Panchayat Raj in detail, decided to accept the same and sanction a sum of Rs.352,50,00,000 (Rupees Three Hundred and Fifty Two Crore and Fifty Lakh only) being balance 50% of fund out of Budget Allocation of Rs.705 Crore for the implementation of Member of Legislative Assembly Constituency Development Scheme for the year 2021-2022 inclusive of one nominated MLA, if any.
