ORDER:

In the Government Order first read above, administrative sanction was accorded for a sum of Rs.470 crore along with the detailed guidelines for the implementation of Member of Legislative Assembly Constituency Development Scheme (MLACDS) for the year 2020-2021. In the Government Order second read above, orders were issued amending the guidelines for the implementation of Member of Legislative Assembly Constituency Development Scheme (MLACDS). In the Government Order third read above, orders were issued releasing Rs.235 crore being 50% of funds out of total fund allocation of Rs.470 crore for the implementation of Member of Legislative Assembly Constituency Development Scheme funds for the year 2020-2021.

2. In the letter fourth read above, the Commissioner of Rural Development and Panchayat Raj has stated that as per the G.O. third read above, Rs.235 crore have been released to the Greater Chennai Corporation and all the District Collectors in the financial year (2020-2021). Now, the balance 50% of the Member of Legislative Assembly Constituency Development Scheme fund needs to be released to the Districts and Greater Chennai Corporation for ensuring of speedy implementation of the scheme in all the Assembly Constituencies.

3. Therefore, the Commissioner of Rural Development and Panchayat Raj has requested the Government to issue necessary orders for the release of balance 50% of the funds and which may be debitable to the respective head of accounts from the Budget Allocation for the year 2021-20 under Member of Legislative Assembly Constituency Development Scheme.

4. The Government, after detailed examination of the proposal of the Commissioner of Rural Development and Panchayat Raj, accord sanction for a sum of Rs.235 crore (Rupees Two hundred and thirty five crore only) being the balance 50% for the implementation of Member of Legislative Assembly Constituency Development Scheme (MLACDS) during 2020-2021.

5. The amount sanctioned in para 4 above, shall be debited to the following Heads of Account:-
