ORDER:

The Director of Rural Development and Panchayat Raj, in the letters read above, has stated that the Hon'ble Minister for Dairy Development has announced on the Floor of the Assembly that 100 Nos. of new buildings will be constructed for the Primary Milk Producers Co-operative Societies at an estimate cost of Rs.10.00 Crore under Mahatma Gandhi National Rural Employment Guarantee Scheme.

2. The Director of Rural Development and Panchayat Raj has also stated that the Commissioner for Milk Production and Dairy Development has sent the district-wise and panchayat union-wise list of 143 Primary Milk Producer Cooperatives having own land in the name of the Society to construct office building and requested to examine whether the list of Primary Milk Producer Co-operatives in 22 Districts except Tiruvallur, Cuddalore, Nagapattinam, Thanjavur, Tiruvarur, Ariyalur, Ramanathapuram, Thoothukudi and Kanniyakumari Districts having own land in the name of the Society can be taken up for construction of Primary Milk Producers Co-operative Society Building under Mahatma Gandhi National Rural Employment Guarantee Scheme.

3. Based on the feasibility report received from the District concerned, the Director of Rural Development and Panchayat Raj has sent the District wise target for the Construction of 50 Primary Milk Producers Co-operative Society Building during 2016-17 under Mahatma Gandhi National Rural Employment Guarantee Scheme in Phase-I and also stated that the remaining 50 numbers to be taken, after getting the enhanced Labour Budget approval under Mahatma Gandhi National Rural Employment Guarantee Scheme by Government of India. The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue orders for the Construction of 50 Primary Milk Producers Co-operative Society Building at the unit cost of Rs.10.00 Lakh under Mahatma Gandhi National Rural Employment Guarantee Scheme during the year 2016-17 in Phase-I, in the following funding pattern :
