ORDER:

In the Government Order first read above, orders were issued according Administrative Sanction for construction of 20,000 Houses for a sum of Rs.499.227 Crore of which 11,197 Houses @ 1.10 Lakh per House for SCs and Others and 8803 Houses @ Rs.3.00 Lakh per House for STs under the Chief Minister's Green House Scheme (CMGHS) for the year 2020-21.

2. In the Government Order second read above, orders were issued releasing Rs.249,61,00,000/- being 50% of funds out of total claim of Rs.499.22 Crore for the implementation of Chief Minister's Green House Scheme (CMGHS) for the year 2020-2021.

3. In the Government Order third read above, orders were issued releasing a sum of Rs.210,00,00,000/- out of the backlog amount of Rs.420 Crore for the period upto 2019-20 for construction of the houses under Chief Minister's Solar Powered Green House Scheme (CMSPGHS).

4. In the Government Order fourth read above, orders were issued releasing the balance amount for a sum of Rs.39,61,00,000/- out of the total cost of Rs.499.22 Crore towards the additional allotment for Tribal beneficiaries under Chief Minister's Green House Scheme (CMGHS) for the year 2020-21.

5. In the Letter fifth read above, the Director of Rural Development and Panchayat Raj has stated that in Budget Estimate for the year 2021-22 only token is provided under Chief Minister's Green House Scheme (CMGHS). Therefore, the balance due amount of Rs.420.01 Crore which includes Rs.210 Crore for 2019-20 and Rs.210.01 Crore for the year 2020-21 under CMGHS has been proposed in Revised Estimate 2021-22 to make necessary provisions. Accordingly, in Revised Estimate for the year 2021-22, a sum of Rs.299 crore is provided for CMGHS under the respective Heads of Account.

6. Hence, the Director of Rural Development and Panchayat Raj has therefore requested the Government to sanction and release a sum of Rs.299 Crore for the implementation of Chief Minister's Green House Scheme (CMGHS) for the year 2021-22.

7. The Government, after detailed examination of the proposal of the Director of Rural Development and Panchayat Raj, have decided to accord sanction and release a sum of Rs. 299,00,00,000/- (Rupees Two Hundred and Ninety Nine Crore only) under Chief Minister's Green House Scheme (CMGHS) for the year 2021-2022.
