### ORDER:

In the letter 4<sup>th</sup> read above, based on the request of Chairman and Managing Director, Tamil Nadu Energy Development Agency (TEDA), the Director of Rural Development and Panchayat Raj has requested sanction of funds to the tune of Rs.156,97,90,279/- for making payment to Tamil Nadu Energy Development Agency (TEDA) towards installation of Solar lights for three lakh houses constructed under Chief Minister’s Solar Powered Green House Scheme (CMSPGHS) 2011-2012 to 2015-2016 as detailed below:-

The Government after careful examination, accept the proposal of the Director of Rural Development and Panchayat Raj and sanction and release a sum of Rs.85.42 Crore (Rupees Eighty Five Crore and Forty two lakh only) available in B.E 2017-18 out of the total claim of Rs.156,97,90,279/- to Tamil Nadu Energy Development Agency (TEDA) through Director of Rural Development and Panchayat Raj to settle pending dues to installers of Solar lights under Chief Minister's Solar Powered Green House Scheme for the year 2011-12 to 2015-16. The Director of Rural Development and Panchayat Raj is directed to send necessary proposal for release of the remaining amount of Rs.71.55 Crore in 2018-19.
