ORDER:

In the letter first read above, the Ministry of Rural Development, Government of India has earmarked 21,000 houses for the year 2018-19 under Pradhan Mantri Awaas Yojana (Gramin) and the same has been allotted to 35 Districts except Kanniyakumari and the Nilgiris Districts. The requirement of fund for 21,000 houses are as follows:-

- 2. The Director of Rural Development and Panchayat Raj has stated that, the Government of India now in its letter 1st read above, has sanctioned a sum of Rs.78.624 Crore as 1st instalment towards Central share including 4% of Admin cost out of Rs.151.20 Crore required for 21,000 houses under Pradhan Mantri Awaas Yojana (Gramin) 2018-19 and the amount has been credited to State Nodal Account (Ac.No.030701000085000) of Pradhan Mantri Awaas Yojana (Gramin).
- 3. In the Government Order 3rd read above, the Government of Tamil Nadu has sanctioned a sum of Rs.52.416 Crore as 1st instalment towards the proportionate State matching share of under Pradhan Mantri Awaas Yojana (Gramin) for the year 2018-19 and the same has been drawn and deposited in State Nodal Account as follows:-

Since, 100% (21,000 houses) of the physical target has been sanctioned under Pradhan Mantri Awaas Yojana (Gramin) 2018-19 and the programme fund released as 1st instalment has been fully utilised, the Ministry of Rural Development, Government of India has been requested to sanction the balance amount of Rs.78.624 Crore including 4% Admin Cost of Central Share towards 2nd instalment under Pradhan Mantri Awaas Yojana (Gramin) for the year 2018-19.

4. In the letter 4th read above, the Ministry of Rural Development, Government of India has released the 1st Tranche of 2nd instalment of Central Share of

Rs.37,80,00,000/- (excluding 4% Admin Cost) for the year 2018-19 and the amount has been credited to the Consolidated Fund of State.

Further, in the para 4 & 5 of the order issued in Letter No.J-12034/1/2021-RH-Accts, dated 22.12.2021, the Ministry of Rural Development, Government of India has stated as;

- i) It is reiterated that while allocating targets to Districts, State should follow the formula prescribed by the Ministry. It is clarified that earmarked targets for SC, ST and Minority cannot be diverted to general category. Only SC and ST targets can be interchanged if there are sufficient justifications.
- ii) State Government should transfer these funds from Consolidated Fund of the State to the bank account of the State implementing agency dedicated to PMAY(G) within 3 days of receipt from the Central Government and in the event of failure on this account, the States will be liable to pay interest @12% per annum for the period of delay. The State share should also be released within 15 days from the date of release of Central share. In case of shortfall in State share, corresponding amount of central share will be deducted from the 2nd instalment. The factum of release of these funds must be registered in the Public Financial Management System (PFMS). The State Government is also requested to invariably endorse the copies of the release orders to the Central Government.
- 5. The Director of Rural Development and Panchayat Raj has therefore requested the Government to accord sanction for Rs.63 Crore for Central and State share and to release the Central Share of Rs.37.80 Crore (Rupees Thirty Seven Crore eighty lakh only) and the corresponding State matching Share of Rs.25.20 Crore (Rupees Twenty five Crore twenty lakh only) towards 1st Tranche of 2nd instalment for the year 2018-19. Further, the Director of Rural Development and Panchayat Raj has request the Government to authorise the Director of Rural Development and Panchayat Raj to draw the funds from the PAO (South), Chennai under the above head of accounts and disburse the amount to the State Nodal Account (Ac.No.030701000085000) of Pradhan Mantri Awaas Yojana (Gramin) maintained in Indian Overseas Bank, Saidapet, Chennai.

- 6. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, have decided to accord sanction for Rs.63,00,00,000/- (Rupees Sixty three crore only) for Central and State share and to release the Central Share of Rs.37,80,00,000/- (Rupees Thirty Seven crore eighty lakh only) and the corresponding State matching Share of Rs.25,20,00,000/- (Rupees Twenty five crore twenty lakh only) towards 1st Tranche of 2nd instalment for the year 2018-19.
- 7. The expenditure sanctioned in para 6 above shall be debited under the following heads of account:-

- 9. The Guidelines of Pradhan Mantri Awaas Yojana (Gramin), Government of India shall be followed strictly. Geo tagging and Social Audit shall also be ensured as

per the Guidelines of Government of India and Utilization Certificate shall be sent to Government of India as per norms with a copy marked to the Government.
