



## ABSTRACT

Centrally Sponsored Schemes – Pradhan Mantri Awaas Yojana(Gramin) (erstwhile Indira Awaas Yojana) - Release of Rs.37,52,84,000/- (Central Share Rs.22,51,74,800 + State Share Rs.15,01,09,200) towards residual allocation of 7770 houses under Indira Awaas Yojana 2015-16 – Sanction accorded – Orders – Issued.

### ORDER:

The Director of Rural Development and Panchayat Raj in the letter third read above, has stated that Government of India originally allotted 53429 houses under Indira Awaas Yojana 2015-16 with a funding pattern of 50:50 between Central and State. Subsequently, the fund sharing pattern of Central and State has been revised as 60:40 instead of 50:50 and the physical target was reduced by Government of India to 45044 houses based on the funds sanctioned under 50:50 sharing pattern. In the meantime, based on the original target of 53429 houses, the sub allocation to the districts were done by the State and beneficiaries were identified and works have commenced in the field, by the time the revised target of 45044 houses are announced.

The Government of India also has released a sum of Rs.19675.290 lakhs including 4% Administrative cost as central share for the revised target of 45044 houses. Accordingly, the corresponding State Share of Rs.35638.813 lakhs was released including 4% Administrative cost and RCC roofing cost. Since the works are commenced in the field for all 53429 houses, the Government of India have been requested to sanction the entire share for 8385 houses (53429 - 45044) which are left out including the admin cost, so that the poor beneficiaries will get funds for the construction of their houses.

2. The Director of Rural Development and Panchayat Raj has also stated that now, Government of India have done the residual allotment of 7770 houses under Indira Awaas Yojana 2015-16. The total Central Share works out to Rs.3393.936 lakhs, which includes 4% admin cost. But, the Government of India have released only Rs.2251.748 lakhs under SC and ST Head of Account and the balance amount of Rs.1142.192 lakhs could not be released due to paucity of funds in the Ministry and the same will be released as soon the funds received from the Ministry. The expenditure for the additional target of 7770 houses under Indira Awaas Yojana 2015-16 is shared on 60:40 basis between the Central and State respectively as follows:-

Accordingly, the State Share is calculated as Rs.61,47,62,400/- (Rs.21,75,60,000/- for houses, Rs.87,02,400/- for 4% Administrative Cost of State Share and Rs.38,85,00,000/- for State additional fund for RCC Roofing cost) for the additional target of 7770 houses under Indira Awaas Yojana 2015-16. Since the Government of India have released only part of the amount under Central Share, it is proposed to



sanction only the proportionate corresponding State share and State additional fund for RCC Roofing cost under SC & ST head of accounts i.e, Rs.4078.592 lakhs along with the central share of Rs.2251.748 lakhs, totaling of Rs.6330.340 lakhs to be released as summarized below:-

The Director of Rural Development and Panchayat Raj has therefore requested the Government to accord sanction for a sum of Rs.63,30,34,000/- (Central Share Rs.22,51,74,800 + State Share Rs.15,01,09,200 + State Additional Fund for RCC Roofing cost Rs.25,77,50,000) and issue necessary orders empowering the Director of Rural Development and Panchayat Raj to draw the above funds towards the residual allocation of 7770 houses under Indira Awaas Yojana 2015-16.

4. The Government, after careful examination of the proposal of the Rural Development and Panchayat Raj Department, accord sanction for a sum of Rs.37,52,84,000/- (Rupees Thirty seven crore fifty two lakh eighty four thousand only)

(Central Share Rs.22,51,74,800/- + State Share Rs.15,01,09,200/-) towards the residual allocation of 7770 houses under Indira Awaas Yojana 2015-16.

5. The amount sanctioned in para 4 above shall be debited under the following head of accounts :-
