Centrally Sponsored Schemes – Pradhan Mantri Gram Sadak Yojana(PMGSY) – Release of a sum of Rs.50,23,00,000/- [Rs.30,14,00,000/- as Central Share(60%) and Rs.20,09,00,000/- as State Share(40%)] towards Financial Incentive under Pradhan Mantri Gram Sadak Yojana for the year 2018-19 for periodic maintenance of roads already constructed under PMGSY Scheme - Orders – Issued.

ORDER :

In the letter second read above, the Director of Rural Development and Panchayat Raj has stated that Ministry of Rural Development has released Rs.30,14,00,000/- towards “Financial Incentive” to State Government as Central assistance under Pradhan Mantri Gram Sadak Yojana for the year 2018-19 for periodic maintenance of roads already constructed under PMGSY Scheme. It is insisted in the Ministry of Rural Development’s letter dated 28.2.2019, that the State Government must transfer their funds to Tamil Nadu Rural Housing and Infrastructure Development Corporation(TNRHIDC) within 3 days from the date of receipt of funds, failing which further releases will be stopped and the State Government shall credit the matching State Share.

2. The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue necessary order on the following:

- I. To release a sum of Rs.50,23,00,000/- [Rs.30,14,00,000/- as Central Share(60%) and Rs.20,09,00,000/- as State Share(40%)] towards Financial Incentive under Pradhan Mantri Gram Sadak Yojana for the year 2018-19 for periodic maintenance of roads already constructed under PMGSY Scheme.
- II. To authorize him to draw the sanctioned amount from Pay and Accounts Officer(South), Chennai-35 and to transfer the same to Tamil Nadu Rural Housing and Infrastructure Development Corporation Account. The amount sanctioned may be debited to the following head of account:

4515–00-Capital outlay on Other Rural Development Programmes – 103 – Rural Development – Schemes shared between State and Centre - UA – Roads/Bridge works under PMGSY-Bharat Nirman–16 Major works.

3. The Government, after a careful examination, have decided to accept the request of the Director of Rural Development and Panchayat Raj and accord sanction a sum of Rs.50,23,00,000/- (Rupees Fifty crore twenty three lakh only) [Rs.30,14,00,000/- as Central Share(60%) and Rs.20,09,00,000/- as State Share(40%)] towards Financial Incentive under Pradhan Mantri Gram Sadak Yojana for the year 2018-19 for periodic maintenance of roads already constructed under PMGSY Scheme.

4. The expenditure sanctioned in para 3 shall be debited under the following head of account:

4515-00-Capital outlay on Other Rural Development Programmes – 103 –
Rural Development – Schemes shared between State and Centre - UA –
Roads/Bridge works under PMGSY-Bharat Nirman-16 Major works.

5. Necessary funds have already been provided in RE 2018-19. The Director of Rural Development and Panchayat Raj is authorized to draw and disburse the amount sanctioned in para 3 above to Tamil Nadu Rural Housing and Infrastructure Development Corporation account.
