



ABSTRACT

Schemes – Mahatma Gandhi National Rural Employment Guarantee Scheme – Enhancement of Wage Rate from Rs.203/- to Rs.205/- under Mahatma Gandhi National Rural Employment Guarantee Scheme(MGNREGS) works notified by the Government of India – Adoption in Tamil Nadu – Revision of Rural Schedule of Rates – Orders issued.

ORDER:

In the Government Order first read above, orders were issued revising the wage rate from Rs.183/- to Rs.203/- per day per person for the unskilled manual workers under Mahatma Gandhi National Rural Employment Guarantee Scheme and revising Rural Schedule of Rates consequently under Mahatma Gandhi National Rural Employment Guarantee Scheme for the unskilled manual workers in Tamil Nadu.

2. The Government of India has notified the Wage Rate payable to the unskilled manual workers under Mahatma Gandhi National Rural Employment Guarantee Scheme in respect of all States/Union Territories with effect from 1.04.2017. The Government of India have enhanced the Wage Rate from Rs.203/- to Rs.205/- per day per person payable for the unskilled manual workers under Mahatma Gandhi National Rural Employment Guarantee Scheme in respect of Tamil Nadu.

3. The Director of Rural Development and Panchayat Raj, in the letter third read above, has stated that the Mahatma Gandhi National Rural Employment Guarantee Act, 2005 was enacted to provide not less than one hundred days of unskilled manual work

as guaranteed employment in a financial year to every household in rural areas as per demand resulting in creation of productive assets of prescribed quality and durability.

4. The Director of Rural Development and Panchayat Raj has stated that based on the Gazette Notification of Government of India in S.O.No.735, dated 23.03.2016, revision of wage rate from Rs.183/- to Rs.203/- per person per day for 2016-17 was carried out and the Rural Schedule of Rates revised in G.O.(Ms) No.48, Rural Development and Panchayat Raj(CGS-1) Department, Dated 04.04.2016. Further, in the G.O.(Ms) No.30, Rural Development and Panchayat Raj(CGS-1) Department, dated 15.03.2017 Government have issued amendment orders to G.O.(Ms) No.48, Rural Development and Panchayat Raj(CGS-1) Department, dated 04.04.2016 regarding revision of rates for watering of plants/trees in the Rural Schedule of Rates 2016-17.

5. The Director of Rural Development and Panchayat Raj has further stated that in the Gazette Notification S.O.No.597, dated 28.02.2017, Government of India has notified revision of wage rate to all States/Union Territories with effect from 1.04.2017. In respect of Tamil Nadu, the wage has been revised as Rs.205/- per person per day. The revision is based on the powers conferred by sub-section(1) of section 6 of the Mahatma Gandhi National Rural Employment Guarantee Act, 2005 (42 of 2005), and is an annual feature. Based on the Government of India's Gazette Notification dated 28.02.2017 on revision of wages as Rs.205/- per day per person for the year 2017-18, the Rural Schedule of Rates has been revised accordingly.

6. The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue necessary orders for revising the wage rate with effect from 01.04.2017 as Rs.205/- per person per day under Mahatma Gandhi National Rural Employment Guarantee Scheme by making changes in the Rural Schedule of Rates.

7. The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, have decided to accept it and accordingly issue the following orders in view of enhancement of Wage Rate under Mahatma Gandhi National Rural Employment Guarantee Scheme by the Government of India:

- (i) Wage Rate under Mahatma Gandhi National Rural Employment Guarantee Scheme for the unskilled manual workers in Tamil Nadu is enhanced from Rs.203/- to Rs.205/- per day per person for the year 2017-18.
- (ii) In order to achieve the minimum wage of Rs.205/- per day per person under Mahatma Gandhi National Rural Employment Guarantee Scheme the Rural Schedule of Rates for the year 2017-18 is revised as mentioned in Annexure-I to this order, Rural Schedule of Rates for the year 2017-18 for Karuvel and all other types of Plantation is revised as mentioned in Annexure-II to this order and Rural Schedule of Rates for the year 2017-18 for Differently-abled persons is revised as mentioned in Annexure-III to this order respectively.

8. This order comes into force with effect from **01.04.2017**.

9. This order is issued with the concurrence of Finance Department vide it's U.O No.15150/RD/2017, dated 28.03.2017.

The special activities identified where the differently-abled workers were able to work for 8 hours and shall be paid the whole wage rate as applicable:-



<u>Special activities</u>	
1) Watermen / Water women at the worksite, who can distribute water to the workers	Rs.205/- per day per person
2) Caretaker to look after the children	
3) Assisting the caretaker for every 5 child one additional assistant can be employed	
4) Assisting the worksite facilitator in premarking (if the No. of worker is above 100 then 1 differently-abled person shall be permitted to assist the worksite facilitator)	
5) Watering (Wetting) the area to be desilted (especially in summer)	

If engaged in minor works related to desilting activities as listed below, the rates for all the items shall be twice that of RSoR fixed for normal persons as noted below:

1) Clearing uprooted jungle scrub jungle, light jungle	50% of the average outturn of the normal person (Twice the rate that of RSoR fixed for the normal persons)
2) Earthwork in all types of soil	
3) Planting	
4) Watering	
5) Breaking clods, tamping & sectioning	
6) Benching old embankment	
7) Any other works covered under RSoR
