### **ORDER:**

In the letter first read above, Ministry of Rural Development, Government of India released a sum of Rs.48,33,00,000/- towards "Financial Incentive" to the State Government as Central assistance under Pradhan Mantri Gram Sadak Yojana(PMGSY) for the financial year 2020-21 for periodic maintenance of roads already constructed under Pradhan Mantri Gram Sadak Yojana(PMGSY). Moreover, it has been insisted that the State must transfer the Central assistance along with the corresponding State matching share within a maximum period of 15 days from the date of receipt of the funds.

2. Pursuant to the above release of funds, in the letter second read above, the Commissioner of Rural Development and Panchayat Raj has requested the Government to issue necessary orders on the following:

- i) To release a sum of Rs.80,55,00,000/- [Rs.48,33,00,000/- as Central Share(60%) and Rs.32,22,00,000/- as State Share(40%)] towards Financial Incentive under Pradhan Mantri Gram Sadak Yojana for the year 2020-21 for periodic maintenance of roads already constructed under PMGSY.
- ii) To empower the Commissioner of Rural Development and Panchayat Raj to draw the sanctioned amount from Pay and Accounts Office(South), Chennai-35 and to transfer the same to Tamil Nadu Rural Housing and Infrastructure Development Corporation's account.

3. The Government, after careful examination of the proposal of the Commissioner of Rural Development and Panchayat Raj, have decided to accept the same. Accordingly, the Government accord sanction and release a sum of Rs.80,55,00,000/- (Rupees Eighty crore fifty five lakh only) [Rs.48,33,00,000/- as Central Share(60%) and Rs.32,22,00,000/- as State Share(40%)] towards Financial Incentive under Pradhan Mantri Gram Sadak Yojana for the year 2020-21 for periodic maintenance of roads already constructed under PMGSY.

4. The expenditure sanctioned in para 3 shall be debited under the following head of account:

103 – Rural Development – Schemes shared between State and

works – 01 - Major works .
