Mahatma Gandhi National Rural Employment Guarantee Scheme – Announcement made by Hon'ble Chief Minister under Rule 110 on the floor of the Legislative Assembly on 09.7.2019 – Establishment of 12,524 Amma Youth Sports Centres in all the 12,524 Village Panchayats covering Volley ball Court, Kabadi Court and either Cricket Pitch or Badminton Court under MGNREGS during 2019-20 – Sanction accorded and Guidelines approved – Orders – Issued.

ORDER:

The Hon'ble Chief Minister under Rule 110 has made the following announcement on the floor of the Legislative Assembly on 09.07.2019:

"கிராமங்களில் உள்ள இளைஞர்களின் ஆரோக்கியத்தையும், மன வளத்தையும் மேம்படுத்தவும் கூட்டு மனப்பான்மையை உருவாக்கவும், இளைஞர்களின் விளையாட்டு திறனை ஊக்குவிக்கவும், அதை வெளிக்கொணரவும் மாண்புமிகு அம்மாவின் அரசால், நடப்பு ஆண்டில் 12 ஆயிரத்து 524 ஊராட்சிகளில் மற்றும் 528 பேரூராட்சிகளில் 64 கோடியே 35 இலட்சம் ரூபாய் மதிப்பீட்டில் "அம்மா இளைஞர் விளையாட்டுத் திட்டம்" என்ற திட்டம் செயல்படுத்தப்படும். இத்திட்டத்தின் கீழ்,

ஒவ்வொரு கிராமத்திலும், கபடி, வாலிபால், கிரிக்கெட், கால்பந்து போன்ற ஏதேனும் மூன்று விளையாட்டுகளுக்கு களம் அமைக்கும் பணிகள், ஊரகப் பகுதிகளில், மகாத்மா காந்தி தேசிய ஊரக வேலை உறுதித் திட்டத்தின் கீழும், பேரூராட்சிகளில் பேரூராட்சிகள் பொது நிதியிலிருந்தும் மேற்கொள்ளப்படும்".

2. Based on the announcement first read above, the Government in Youth Welfare and Sports Development Department have issued orders in G.O.(Ms.)No.36, Youth Welfare and Sports Development (S2) Department, dated:22.10.2019, for financial sanction of Rs.76,23,09,300/- for establishing Amma Youth Sports Centres in all the 12,524 Village Panchayats covering any three out of Volley ball Court, Kabadi Court and either Cricket or Badminton or any other sports.

3. Based on the orders issued in Youth Welfare and Sports Development Department, the Director of Rural Development and Panchayat Raj has sent a proposal stating that the unit cost of the Volley ball, Kabadi, Cricket and Badminton Courts are as follows:

- 4. The Director of Rural Development and Panchayat Raj has therefore, requested that the Government to accord permission for establishing 12,524 Amma Youth Sports Centres in all the 12,524 Village Panchayats covering Volley ball Court, Kabadi Court and either Cricket Pitch or Badminton court under Mahatma Gandhi National Rural Employment Guarantee Scheme during the financial year 2019-20 and approve the guidelines therefor.
- 5. The Government after careful examination, have decided to accept the proposal of the Director of Rural Development and Panchayat Raj and accord sanction for establishing 12,524 Amma Youth Sports Centres in all the 12,524 Village Panchayats covering Volley ball Court, Kabadi Court and either Cricket

Pitch or Badminton Court under Mahatma Gandhi National Rural Employment Guarantee Scheme during the financial year 2019-20, subject to condition that the financial sanction may be approved after getting the release of Central Share. The Government also approve the guidelines as annexed to this order.

- 6. Three stage photograpy i.e. before, during and after the work, shall be done.
 - 7. Geo-tagging of all assets shall be done.
- 8. Government of India and State Government guidelines shall be followed strictly.
 - 9. Utilisation Certificate shall be sent immediately.
- 10. This order is issued with the concurrence of Finance Department vide its U.O.No.8616/Fin.(RD)/2020, dated:21.02.2020.

Guidelines for establishing of Amma Rural Youth Sports Centre in the Village Panchayats

Introduction

The Government of Tamil Nadu has launched several schemes to encourage sports activities among youth in the state, to promote physical strength with mental well being and spirit of friendly competition, which in turn, has positive impact on the overall personality development of the youth.

Need for Rural Sports Centres

The Hon'ble Chief Minister has made an Announcement on the floor of the Assembly under Rule 110 on 09.07.2019 that,

Further in G.O.(Ms.)No.36, Youth Welfare and Sports Development (S2) Department, dated:22.10.2019, Government have issued financial sanction of Rs.76,23,09,300/- for establishing Amma youth sports Centres in all the 12,524 Village Panchayats covering any three out of Volley ball Court, Kabadi Court and Cricket or Badminton or any other sports. Further, the Government have issued orders that Play field/Pitch will be constructed under Mahatma Gandhi National Rural Employment Guarantee Scheme in all 12,524 village panchayats.

Accordingly, it is proposed to develop minimum one Amma Rural Youth Sports Centre per Village Panchayat, considering the size of Village Panchayats and based on the availability of land, additional sports Amma Rural Youth Sports Centres may also be taken-up.

During 2019-20, it is proposed to develop 15,000 Amma Rural Youth Sports Centres by the Government of Tamil Nadu. The development of play grounds for the Amma Rural Youth Sports Centre will be taken up in convergence under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) covering any three out of Volley ball Court, Kabadi Court and Cricket or Badminton or any other sports during the financial year 2019-20.

District Level Committee

A committee will be constituted at the District level for Amma Rural Youth Sports Centre and the committee will monitor the establishment and development of infrastructures for Amma Rural Youth Sports Centre in all the Village Panchayats in the district. The identified site for the establishment of Amma Rural Youth Sports Centre should be approved by the District Level Committee.

Location and Facilities:

Amma Rural Youth Sports Centre should be located in any unobjectionable Poromboke / Poromboke lands vested with Panchayats adjacent to the habitations having the required extent of land. If Poromboke land is not available, sports centre may be located in the Government / Panchayat Union schools. The following facilities shall be provided in the sports centre.

Any three out of Volley ball Court, Kabadi Court and Cricket or Badminton or any other sports can be taken up by the Village Panchayats as per the availability of Site.

The size required for each sport is given below.

Identification of site:

The Village Panchayat will identify the suitable site in consultation with the Village Administrative Officer (VAO) and the local youth. The site proposed should not be a low lying or water logged area. Elevated surface shall be selected for formation of play ground. It is not compulsory to provide all courts in a single location and it may be split, according to the availability of site and local needs.

The concerned Assistant Engineer / Junior Engineer / Overseer will inspect the identified site and submit a feasibility report to the Block Development Officer (VP). The Block Development Officer (VP) will consolidate the report along with the approval of the Grama Sabha and submit it for scrutiny and approval of District Level Committee headed by the District Collector. Based on the approval of the District Level Committee, administrative sanction will be accorded by the District Collector.

Technical Specification:

- Based on the availability of land, play ground is usually constructed in a square or rectangular shape.
- The Assistant Engineer (RD) / Block Engineer shall ensure that the technical specifications are adhered to and the estimate costs of the proposed works have been correctly arrived at.
- Levelling the Ground surface by cutting /filling including compaction by using power roller and it should be specifically mentioned in the estimate and in the administrative sanction.
- Proper slope should be maintained so that the water gets drained off easily.
- Brick pitching to be provided in the corners for Volleyball, Kabadi and Badminton court without projecting above ground level so as to demarcate the boundary.
- Provision of Infrastructure for play grounds shall be approved by the Gram Sabha and shall also be part of the annual shelf of projects of the Village Panchayat identified under Mahatma Gandhi National Rural Employment Guarantee Scheme.
- The Administrative & Financial sanction for the play grounds to be constructed under Mahatma Gandhi National Rural Employment Guarantee Scheme will follow the process defined for Mahatma Gandhi National Rural Employment Guarantee Scheme works, like creation of estimates according Administrative Sanction and Technical Sanction in SECURE, 3 - stage Geo tagging, establishing Citizen Information Board, etc.,

Execution Mode

The development of play grounds in Amma Rural Youth Sports Centre will be taken-up under Mahatma Gandhi National Employment Guarantee Scheme (MGNREGS).

The Mahatma Gandhi National Rural Employment Guarantee Act, 2005, Schedule I, Clause IV, category D item (iii) permits the "Construction of play fields and compound walls for Government run schools in the villages". Further, the Annual Master Circular 2019-20 under section 7.2 of list of permissible works, item no. 38 permits the "construction of play fields". Hence, development of play ground is a permitted activity in rural villages may be taken up under Mahatma Gandhi National Employment Guarantee Scheme.

Maintenance of the Amma Rural Youth Sports Centre

Maintenance of the rural sports centre shall be the responsibility of the respective village Panchayat, as this is one of the duty cast upon the Village Panchayats under the section 111 (H) of the Tamil Nadu Panchayat Act 1994 and it states that "the establishment and maintenance of wireless receiving sets, playgrounds, parks, sports clubs and centres of physical culture;". Accordingly, the Village Panchayat shall however encourage the formation of the youth sports centre in their Villages and these centres shall, in due course, take over the responsibility of the operation and maintenance of the sports centre.

The District Collectors shall actively involve the District Sports Officer (DSO) and the officer of the Sports Development Department for setting up of the Amma Rural Youth Sports Centre in all the Village Panchayats.

The District Collector shall review the progress of construction of play ground and installation at the Village Panchayats. The Project Director, District Rural Development Agency is responsible for monitoring the establishment of Amma Rural youth sports centre in all Village Panchayats at District level. Nodal Officers in the cadre of Assistant Director should be appointed by the District Collector to supervise and monitor the progress of construction of play ground.

Non-Negotiables in Work Execution:

The construction of play grounds will be subject to all Mahatma Gandhi National Rural Employment Guarantee Act processes and conditionality, such as:-

- Citizen information board shall be kept at the worksite in 3 x 4 feet with all necessary information as per frame work given by the Government of India vide Ref.No.K-11023/1/2017–MGNREGA(IV), Ministry of Rural Development, dated:07.04.2017 since this is a community type structure, the cost of Citizen information board is fixed at Rs.4,500/- per unit which will be covered in the cost of the information board and included in the estimate itself at the rate of Rs.1500/- each. The Citizen information board shall be erected in the prominent site identified for the development of infrastructure for Amma Rural Youth Sports Centre.
- Geo tagging of the assets shall be done for all 3 stages namely before, during and after completion of the work.
- No contractor and machineries will be deployed unless otherwise specified in the Administrative Sanction accorded by the District Collector.
- Mahatma Gandhi National Rural Employment Guarantee Scheme work file (Checklist/Contents) as per the instructions of Government of India, vide Ref. No.J-11017/6/2016 – MGNREGA (VII), Ministry of Rural Development, dated 21.12.2016 has to be maintained for all works.
- The Rural Schedule of Rate finalised in G.O.(Ms.)No.52, Rural Development and Panchayat Raj (CGS.1) Department, dated: 09.04.2019 and G.O.(Ms.)No.53, Rural Development and Panchayat Raj (CGS.1) Department, Dated:15.04.2019 shall be adopted. In case of any revision made in Rural Schedule of Rates in future, the same shall be adopted in this current financial year.

The Additional Chief Secretary to Government, Rural Development and Panchayat Raj Department is empowered to modify the guidelines issued for this Scheme whenever necessary in consultation with the Director of Rural Development and Panchayat Raj.
