



ABSTRACT

Schemes – Central Assistance to District Rural Development Agencies sanction and release of the payment of Grants-in-aid amounting to Rs.11,29,06,000/- (Rupees Eleven Crore Twenty Nine Lakhs and Six Thousand only) (Central share Rs.5,64,53,000 + State Share Rs.5,64,53,000) towards additional instalment for implementation of the District Rural Development Agency Administration Scheme for the financial year 2016-17 to the 31 District Rural Development Agencies - Orders – Issued.

ORDER:

The Government of India, Ministry of Rural Development in the letter first read above, has sanctioned the payment of Grants-in-aid amounting to Rs.5,64,53,000/- (Rupees Five Crore Sixty Four Lakhs and Fifty Three Thousand Only) towards additional instalment of Central share for implementation of the District Rural Development Agency Administration Scheme for the financial year 2016-17 to the 31 District Rural Development Agencies.

2. The release is subject to the following conditions:-

- (a) A separate Bank Account in a nationalized Bank shall be maintained under District Rural Development Agency.
- (b) State Government should transfer these funds to the bank accounts of concerned District Rural Development Agency(s) within 10 days of their receipt from the Central Government and in the event of failure on this account, the State will be liable to pay the interest @12% per annum for the period of delay.
- (c) The quantum of release is subject to actual requirement within the overall ceiling. Any expenditure over and above the ceiling shall be met by the State Government.

- (d) The Funds would not be diverted to any purpose other than meeting the expenditure on salary and contingency as per the Guidelines of the Scheme.
- (e) The State Government should also release its contribution towards the overall cost of District Rural Development Agency Administration within 15 days. In case of shortfall in State share, corresponding amount of Central share will be deducted from the 2nd installment of next financial year.
- (f) The State Government is also requested to invariably endorse / send copy (-ies) of the release orders within 3 days to the Central Government.

3. The funding pattern under the scheme will be 50:50 between Centre and State. However there is no bar on releasing more funds by the State than its due share to meet the genuine requirement of a District Rural Development Agency. The Utilization of funds should be in accordance with the District Rural Development Agency Administration guidelines.

4. The Accounts of the grantee institutions / District Rural Development Agencies will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development under Chief Controller of Accounts, in terms of Rule 211 (1) and 211 (2) of the General Financial Rules.

5. In the letter second read above, the Director of Rural Development and Panchayat Raj has requested the Government to release a sum of Rs.11,29,06,000/- (Rupees eleven crore twenty nine lakhs and six thousand only) (Central share Rs.5,64,53,000 + State Share Rs.5,64,53,000) towards additional instalment of Central and State share for implementation of the District Rural Development Agency Administration Scheme for the financial year 2016-17 to the 31 District Rural Development Agencies.

6. The Government have accepted the proposal of the Director of Rural Development and Panchayat Raj and accordingly release the payment of Grants-in-aid amounting to Rs.11,29,06,000/- (Rupees eleven crore twenty nine lakhs and six thousand only) (Central share Rs.5,64,53,000 + State Share Rs.5,64,53,000) towards additional instalment of Central and State share for the implementation of the District Rural Development Agency Administration Scheme for the financial year 2016-17 to the 31 District Rural Development Agencies annexed to this Government order.

7. The expenditure sanctioned in para 6 above shall be debited under the following head of account:-

“2515-00 other Rural Development Programmes – 800 other expenditure – States Expenditure – JZ District Rural Development Agency’s Administration cost – 09 Grants-in-Aid-03 Grants for Specific Schemes”
(DPC 2515 00 800 JZ 0938)

8. The Director of Rural Development and Panchayat Raj is authorized to draw and disburse the amount sanctioned in para 6 above to the District Rural Development Agencies in 31 District through ECS as per annexure attached to this Government order.

9. The Project Director, District Rural Development Agencies of concerned Districts is requested to adhere to the instructions contained in the sanction order issued by the Government of India, Ministry of Rural Development and properly report the release details while sending the Utilization Certificate and in the claim proposal to Government of India.

10. This order is issued with the concurrence of Finance Department vide its U.O.No.18650/DS(TS)/Fin(RD)/17, dated 10.04.2017.
