ORDER:

In the letter second read above, the Commissioner of Rural Development and Panchayat Raj has stated that the Government of India in the letter 1st read above, have sanctioned a sum of Rs.6,67,40,500/- as Central Assistance towards conducting Social Audit in the State and staffing of independent Social Audit Unit for the financial year 2020-21. The financial assistance is released to the State Independent Social Audit Unit as part of the 1st installment of 1st tranche based on the 0.25% of expenditure incurred under Mahatma Gandhi National Rural Employment Guarantee Act during the Financial Year 2019-20.

2. The Government of India have also requested the State Government to transfer the funds to the Social Audit Unit's Bank account within 15 days of receipt of the funds and provide the Ministry with a certificate denoting the transfer of funds to the Social Audit Unit Account as below:-

Therefore the Commissioner of Rural Development and Panchayat Raj has requested orders of Government to sanction a sum of Rs.6,67,40,500/- as part of 1stinstallment of 1sttranche to the State Government of Tamil Nadu as Central Assistance towards conducting Social Audit in the State and staffing of independent Social Audit Unit for the financial year 2020-21 and to permit him to draw and transfer the amount to the Social Audit Society of Tamil Nadu (SASTA).

The Government after careful examination of the proposal of the Commissioner of Rural Development and Panchayat Raj, accord sanction for a sum of Rs.6,67,40,500/- (Rupees Six Crore Sixty Seven lakh Forty Thousand and Five Hundred only)as part of 1stinstallment of 1sttranche as Central Assistance towards conducting Social Audit in the State and staffing of independent Social Audit Unit for the financial year 2020-21.
