

#### **ABSTRACT**

Mahatma Gandhi National Rural Employment Guarantee Scheme – Announcement made by Hon'ble Minister (Food and Civil Supplies) for the year 2021-22 – Construction of 50 numbers of Direct Purchase Centres at a unit cost of Rs.28.94 Lakh and total estimated cost of Rs.14.47 Crore under Mahatma Gandhi National Rural Employment Guarantee Scheme 2021-22 – Permission accorded – Orders – Issued.

### **ORDER:**

The Hon'ble Minister (Food and Civil Supplies) made the following Announcement in the floor of the Legislative Assembly on 25.08.2021:-

"50 நேரடி நெல் கொள்முதல் நிலையங்கள் மகாத்மா காந்தி தேசிய ஊரக வேலைவாய்ப்பு திட்ட நிதியின் கீழ் ரூ.17 கோடி மதிப்பீட்டில் அமைக்கப்படும்".

2. Based on the above Announcement, the Managing Director, Tamil Nadu Civil Supplies Corporation has submitted the Direct Purchase Centre Type Design at an estimated cost of Rs.34.00 lakh / each along with District-wise proposed locations and requested orders of the Government for taking up the work under Mahatma Gandhi National Rural Employment Guarantee Scheme during 2021-22.

3. In this regard, the proposal from the Director of Rural Development and Panchayat Raj was called for and the Director of Rural Development and Panchayat Raj has submitted proposal to Government stating that, based on the Mahatma Gandhi National Rural Employment Guarantee Scheme, RSoR, the unit cost for construction of Direct Purchase Centre is Rs.28.94 Lakhs / building. For total Cost of Rs.14.47 Crore for 50 No's of Direct Purchase Centres, the Government of India and Government of Tamil Nadu share is as follows:

Central Share:	= Rs.1.25 Crore + Rs.9.92 Crores
(100% labour component + 75% Material component)	= Rs.11.17 Crores
State Share:	
(25% Material component)	= Rs.3.30 Crores

The Type Design details of the Direct Purchase Centre is,

S.No.	Direct Purchase Centre (Type-II)
1.	Plinth area is around 290.27 sq.m
2.	Building consists of open platform, covered yard, Godown, rooms for gunny, office & farmer shed
3.	Yard portion & open platform is of Sloped roof with Trusses and corrugated Asbestos cement sheet roofing.
4.	Purpose of the building is to store paddy/other food grain which are purchased from Farmers.

- 4. The Director of Rural Development and Panchayat Raj has further stated that the regular sharing pattern for Material component under Mahatma Gandhi National Rural Employment Guarantee Scheme between Central and Share is 75:25 respectively. The same sharing pattern has been adopted in the proposal for Direct Purchase Centers which amounts to Rs.9.92 Crore under Central share and Rs.3.30 Crore under State share for Material Component.
- 5. Therefore the Director of Rural Development and Panchayat Raj has requested the Government to accord permission for the Construction of 50 numbers of Direct Purchase Centres at a unit cost of Rs.28.94 Lakh and total estimated cost of Rs.14.47 Crore under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2021-22.
- 6. The Government, after careful examination, have decided to accept the proposal of Director of Rural Development and Panchayat Raj and accord permission

for the Construction of 50 numbers of Direct Purchase Centres at a unit cost of Rs.28.94 Lakh and total estimated cost of Rs.14.47 Crore under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2021-22, subject to the condition that the Financial sanction shall be made only after receipt of Government of India share and the Direct Purchase Centres should be selected only for a location where procurement has happened for five continous years and serves at least 100 ha. of paddy field.
