ORDER:

In the letter read above, the Director of Rural Development and Panchayat Raj has stated that the Central Empowered Committee have approved to the Labour Budget for State of Tamil Nadu for the year 2021-22 at 25 crore persondays and the wage rate is approved for Rs.273/- per person day and hence, the State of Tamil Nadu is entitled for Rs.6825 crore. The Government of India have approved the Labour Budget for State of Tamil Nadu from current 25 persondays to 27.20 crore and from current 27.20 crore persondays to 31.14 core for the year 2021-22.

- 2. The Director of Rural Development and Panchayat Raj has further stated that, now the Government of India, have sanctioned a sum of Rs.724,17,00,000/- (Rupees Seven Hundred and Twenty Four Crore Seventeen Lakh Only) towards Material component and Rs.49,32,18,000/- (Rupees Forty Nine Crore Thirty Two lakh and Eighteen Thousand Only) towards Admin component as 1st installment of 2nd Tranche of Central Assistance for implementation of the Mahatma Gandhi National Rural Employment Guarantee Act for the financial year 2021-22 on condition that the State Government must transfer these funds along with the State share to the State Employment Guarantee Fund for programme implementation within 3 days of receipt of funds failing which the State Government would be liable to pay a penal interest of 12% for the period of delay beyond the specified period.
- 3. The Director of Rural Development and Panchayat Raj, has further stated that the expenditure per person-day generation of wage employment shall have wage and material costs in the proportion of 60:40. The cost of wages is 100% borne by Government of India and as per Rule 22(1)(b) and (2)(b) of the NREGA Act 2005 the

expenditure on material component including wages of skilled and semi-skilled labour will be shared between Centre and State Government in the ratio of 75:25. The administrative cost is 100% borne by Government of India. Hence, taking into account the Government of India release 75% share of material component Rs.674,84,82,000/-(Rupees Six Hundred and Seventy Four Crore Eighty Four Lakh Eighty Two Thousand Only), the State has to bear the balance 25% of the cost of the material component which amount to Rs.224,94,94,000/- (Rupees Two Hundred and Twenty Four Crore Ninety Four Lakh and Ninety Four Thousand Only).

- 4. The Director of Rural Development and Panchayat Raj has therefore requested the Government to sanction a sum of Rs.674,84,82,000/- (Rupees Six Hundred and Seventy Four Crore Eighty Four Lakh Eighty Two Thousand Only) towards Material component as 1st instalment of 2nd tranche of Central Assistance for the year 2021-22 along with the proportionate State Share of Rs.224,94,94,000/- (Rupees Two Hundred and Twenty Four Crore Ninety Four Lakh and Ninety Four Thousand Only) and Rs.49,32,18,000/- (Rupees Forty Nine Crore Thirty Two lakh and Eighteen Thousand Only) towards Admin cost, totaling Rs.949,11,94,000/- (Rupees Nine Hundred and Forty Nine Crore Eleven Lakh Ninety Four Thousand Only) under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2021-22 and to permit him to draw and disburse the amount to the State Employment Guarantee Fund of Tamil Nadu.
- 5. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction for a sum of Rs.674,84,82,000/- (Rupees Six Hundred and Seventy Four Crore Eighty Four Lakh Eighty Two Thousand Only) towards Material component as 1st instalment of 2nd tranche of Central Assistance for the year 2021-22 along with the proportionate State Share of Rs.224,94,94,000/- (Rupees Two Hundred and Twenty Four Crore Ninety Four Lakh and Ninety Four Thousand Only) and Rs.49,32,18,000/- (Rupees Forty Nine Crore Thirty Two lakh and Eighteen Thousand Only) towards Admin cost, totaling Rs.949,11,94,000/- (Rupees Nine Hundred and Forty Nine Crore Eleven Lakh Ninety Four Thousand Only).
