## **ORDER:**

In the letter first read above, Ministry of Rural Development, Government of India have communicated the physical target of 1,30,214 houses for the year 2017-18 under Pradhan Mantri Awaas Yojana(Gramin) and the physical target has been distributed to the districts.

2. The Director of Rural Development and Panchayat Raj has stated that in the letter second read above, the Government of India have sanctioned a sum of Rs.487,52,12,000/- towards the 1<sup>st</sup> installment of Central share under Pradhan Mantri Awaas Yojana(Gramin) 2017-18 and in the Government Order third read above, the Government have accorded sanction for a sum of Rs.812,53,53,440/- (Central share Rs.487,52,12,000/- + State share Rs.325,01,41,440/-) towards 1<sup>st</sup> installment under Pradhan Mantri Awaas Yojana (Gramin) for the year 2017-18.

4. The Director of Rural Development and Panchayat Raj has stated that the proposal has been sent to Ministry of Rural Development, Government of India for claiming 2<sup>nd</sup> Installment of Central Share including 4% Administrative cost to the tune of Rs.487.52 crore under Pradhan Mantri Awaas Yojana(Gramin)2017-18 and accordingly Government of India has sanctioned a sum of Rs.300,01,30,000 towards the part of 2<sup>nd</sup> installment of Central share under the Scheduled Caste and Scheduled Tribe Heads including 4% admin cost (for all categories) leaving a balance of Rs.187,50,82,000/- under Pradhan Mantri Awaas Yojana(Gramin) 2017-18.

5. In the Government order sixth read above, the Government have sanctioned a sum of Rs.500,02,17,040/- (Central share of Rs.300,01,30,000/- + State Share of Rs.200,00,87,040/-) towards the part of  $2^{nd}$  installment of Central and State share for SC and ST Heads including 4% admin cost under Pradhan Mantri Awaas Yojana(Gramin) 2017-18.

6. The Director of Rural Development and Panchayat Raj has further stated that in the letter seventh read above, the Government of India has now released a sum of Rs.187,50,82,000/- towards the balance part of 2<sup>nd</sup> installment of Central share under the Other category under Pradhan Mantri Awaas Yojana(Gramin) 2017-18 and the amount has been directly credited to State Nodal Account on 04.02.2020.

The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj accord sanction for a sum of Rs.125,00,54,400/- (Rupees One hundred and Twenty five Crore Fifty four thousand and Four hundred only) for the balance part of 2<sup>nd</sup> installment of state share for "Others" category under Pradhan Mantri Awaas Yojana (Gramin) for the year 2017-18.

9. The expenditure sanctioned in para 8 above shall be debited under the following heads of account:-
