ORDER:

In the letter second read above, Director of Rural Development and Panchayat Raj has stated that during the year 2018-19, the Government of India have sanctioned a sum of Rs.11,56,44,000/- as 1st and 2nd installment as Central share under DRDA Administration Scheme. Accordingly, the State Government has released the State Share of Rs.7,70,96,000/- as 1st and 2nd installment during 2018-19 in the funding pattern of 60:40 for the implementation of DRDA Administration Scheme. A total sum of Rs.19,27,40,000/- has so far been released to 31 Districts under District Rural Development Agency Administration Scheme for the year 2018-19 as given below:

The funding pattern under the DRDA Administration Scheme will be 60:40 between Centre and State, subject to the ceiling/norms prescribed in the Guidelines on DRDA Administration Scheme. As per the guidelines issued by the Government of India, the State Government has to release a sum of Rs.70.68 lakh being the proportionate 40% share to 31 DRDAs as detailed below:-

The Director of Rural Development and Panchayat Raj has requested the Government to issue necessary orders for the sanction a sum of Rs.1,76,70,000/-[(Rs.1,06,02,000/- as Central Share(60%) + Rs.70,68,000/- as State Share(40%)] towards additional installment for implementation of the District Rural Development Agency Administration Scheme for the year 2018-19 to the 31 District Rural Development Agencies thereby authorizing the Director of Rural Development and Panchayat Raj to draw and disburse the amount to the District Rural Development Agencies concerned.

- 4. After careful examination, the Government have accepted the proposal of Director of Rural Development and Panchayat Raj and accordingly sanction a sum of Rs.1,76,70,000/- (Rupees One crore seventy six lakh seventy thousand only) [(Rs.1,06,02,000/- as Central Share(60%) + Rs.70,68,000/- as State Share(40%)] towards additional installment for implementation of the District Rural Development Agency Administration Scheme for the year 2018-19 to the 31 District Rural Development Agencies as annexed to this Government Order.
 - 5. The expenditure sanctioned in para 4 above shall be debited under the following head of account:

- 6. The Director of Rural Development and Panchayat Raj is authorised to draw and disburse the amount sanctioned in para 4 above to the District Rural Development Agency in 31 districts through ECS as per annexure attached to this Government Order.

The Project Director, District Rural Development Agencies of concerned District is instructed to adhere to the instructions concerned in the sanction order issued by the Government of India, Ministry of Rural Development and properly report the release details while sending the Utilization Certificate and in the claim proposal to Government of India.
