#### **ORDER:**

In the Government Orders first to sixth read above, orders have been issued for release of the Central Share of Rs.119927.75 lakh towards material component along with the proportionate 25% State Share of Rs.39975.91 lakh for material component and Rs.23985.55 lakh towards Administrative Component.

2. The Commissioner of Rural Development and Panchayat Raj in his letter 8<sup>th</sup> read above has stated that the Government of India in the reference 7<sup>th</sup> read above have now sanctioned a sum of Rs.390,89,00,000/- (Rupees Three Hundred and Ninety Crore and Eighty Nine Lakh Only) towards Material component and Admin component as 1<sup>st</sup> installment of 2<sup>nd</sup> Tranche of Central Assistance for implementation of the MGNREGA for the financial year 2020-21 on condition that the State Government Guarantee Fund for programme implementation within a maximum period of 15 days from the receipt of Central funds in the State Treasury. The expenditure per person-day generation of wage employment shall have wage and material costs in the proportion of 60:40. The cost of wages is 100% borne by Government of India and as per Rule 22(1)(b) and (2)(b) of the NREGA Act 2005, the expenditure on material component including wages of skilled and semi-skilled labour will be shared between Centre and State Government in the ratio of 75:25. The administrative cost is 100% borne by Government of India.

3. Hence, considering the above Government of India release amount as 30% Government of India share towards Material Component including 6% Administrative Cost, out of the amount of Rs.390,89,00,000/- (Rupees Three Hundred and Ninety Crore and Eighty Nine Lakh Only), Rs.65,14,83,333/- (Rupees Sixty Five Crore Fourteen Lakh Eighty Three Thousand Three Hundred and Thirty Three Only) is arrived as 6% for Administrative Component and Rs.325,74,16,667/- (Rupees Three Hundred and Twenty Five Crore Seventy Four Lakh Sixteen Thousand Six Hundred and Sixty Seven Only) towards 30% Material component. Taking into account of the above release of material component as 75% share of Government of India, the State has to bear the balance 25% of the cost of the material component which amount to Rs.108,58,05,556/- (Rupees One Hundred and Eight Crore Fifty Eight Lakh Five Thousand Five Hundred and Fifty Six only).

4. The Commissioner of Rural Development and Panchayat Raj has therefore requested orders of Government to sanction a sum of Rs.325,74,16,667/- (Rupees Three Hundred and Twenty Five Crore Seventy Four Lakh Sixteen Thousand Six Hundred and Sixty Seven Only) towards Material component as 1<sup>st</sup> installment of 2<sup>nd</sup> tranche of Central Assistance for the year 2020-21 along with the proportionate State Share of Rs.108,58,05,556/- (Rupees One Hundred and Eight Crore Fifty Eight Lakh Five Thousand Five Hundred and Fifty Six only) and Rs.65,14,83,333/- (Rupees Sixty Five Crore Fourteen Lakh Eighty Three Thousand Three Hundred and Thirty Three Only) towards Admin cost, totalling Rs.499,47,05,556/- (Rupees Four Hundred and Ninety Nine Crore Forty Seven Lakh Five Thousand Five Hundred and Fifty Six only) under MGNREGA for the year 2020-21 and requested to permit him to draw and transfer the amount to the State Employment Guarantee Fund of Tamil Nadu.

5. The Government after careful examination of the proposal of the Commissioner of Rural Development and Panchayat Raj, accord sanction for a sum of Rs.325,74,16,667/- (Rupees Three Hundred and Twenty Five Crore Seventy Four Lakh Sixteen Thousand Six Hundred and Sixty Seven Only) towards Material component as 1<sup>st</sup>instalment of 2<sup>nd</sup> tranche of Central Assistance for the year 2020-21 along with the

proportionate State Share of Rs.108,58,05,556/- (Rupees One Hundred and Eight Crore Fifty Eight Lakh Five Thousand Five Hundred and Fifty Six only) and Rs.65,14,83,333/- (Rupees Sixty Five Crore Fourteen Lakh Eighty Three Thousand Three Hundred and Thirty Three Only) towards Admin cost, totalling Rs.499,47,05,556/- (Rupees Four Hundred and Ninety Nine Crore Forty Seven Lakh Five Thousand Five Hundred and Fifty Six only) under MGNREGA for the year 2020-21.

6. The expenditure sanctioned in para 5 above shall be debited to the following heads of account:
