ORDER:

The Director of Rural Development and Panchayat Raj in the letter 7th read above, has stated that the Empowered Committee has scrutinized and agreed to the Labour Budget proposal of 31.55 Crore persondays for the State of Tamil Nadu for the year 2016-17 in Ministry of Rural Development, Government of India letter

No.J-12034/1/2016-MGNREGA-VI(347654), dated 6.03.2016. The Government of India vide letter No.J-12034/2/2016-MGNREGA-VI, Sl.No.30, dated 22.04.2016, letter No.J-12034/2/2016-MGNREGA-VI, Sl.No.67, dated 19.05.2016, letter No.J.12034/2/2016-MGNREGA-VI, Sl.No.83, dated 24.06.2016, letter No.J-12034/2/2016-MGNREGA-VI, Sl.No.106, dated 08.09.2016, letter No.J-12034/2/2016-MGNREGA-IV, Sl.No.109, dated 15.09.2016 and letter No.J-12034/2/2016-MGNREGA-VI, Sl.No.118, dated 3.11.2016 released a sum of Rs.3158.4508 Crore (ie., Rs.749.7660 Crore + Rs.408.6848 Crore + Rs.1200.00 Crore + Rs.500.00 Crore + Rs.200.00 Crore + Rs.100.00 Crore) to Tamil Nadu as part of 1st tranche of Central Assistance for implementation of the Mahatma Gandhi National Rural Employment Guarantee Act. Accordingly Government have accorded sanction for release of a sum of Rs.749.7660 Crore, Rs.408.6848 Crore, Rs.1200.00 Crore, Rs.500.00 Crore, Rs.200.00 Crore and Rs.100.00 Crore vide G.O.(Ms).No.52, Rural Development and Panchayat Raj(CGS.1) Department, dated 28.04.2016, G.O.(Ms).No.62, Rural Development and Panchayat Raj(CGS.1) Department, dated 26.05.2016, G.O.(Ms).No.78, Rural Development and Panchayat Raj(CGS.1) Department, dated 04.07.2016, G.O(Ms).No.108, Rural Development and Panchayat Raj(CGS.1) Department, dated 19.09.2016, G.O.(Ms).No.114, Rural Development and Panchayat Raj(CGS.1) Department, dated 28.09.2016 and G.O.(Ms).No.135, Rural Development and Panchayat Raj(CGS.1) Department, dated 14.11.2016 respectively.

2. The Director of Rural Development and Panchayat Raj has further stated that in Ministry of Rural Development, Government of India Letter No.J.12034/2/2016-MGNREGA-VI, Sl.No.144, dated 5.01.2017 the Government of India have released a sum of Rs.48,00,00,000/- (Rupees Forty Eight Crore Only) towards Material and Administrative component to Tamil Nadu as 7th part of 1st tranche of Central Assistance for implementation of the Mahatma Gandhi National Rural Employment Guarantee Act for the financial year 2016-17 on condition that the State Government must transfer these funds along with the State share to the State Employment Guarantee Fund for programme implementation within 3 days of receipt of funds failing which the State Government would be liable to pay a penal interest of 12% for the period of delay beyond the specified period.

3. The Director of Rural Development and Panchayat Raj has therefore requested the order of the Government on the following:-

- a) to sanction a sum of Rs.48,00,00,000/- (Rupees Forty Eight Crore Only) towards Material and Administrative component as 7th part of 1st tranche of Central Assistance for the year 2016-17 from the relevant head of account; and
- b) to permit the Director of Rural Development and Panchayat Raj, Chennai to draw and transfer the amount to the State Employment Guarantee Fund of Tamil Nadu.

4. The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction for a sum of Rs.48,00,00,000/- (Rupees Forty Eight Crore Only) towards Material and Administrative component 7th part of 1st tranche of Central Assistance under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2016-17.

5. The expenditure sanctioned in para 4 above shall be debited to the following Head of account :
