### **ORDER:**

In the Government Orders 1<sup>st</sup> and 2<sup>nd</sup> read above, orders have been issued for revision of wage rate from Rs.229/- to Rs.256 per person per day with effect from 01.04.2020.

2. The Commissioner of Rural Development and Panchayat Raj in his letter 4<sup>th</sup> read above has stated that, now the Government of India have notified revision of wage rate to all States/Union Territories with effect from 1<sup>st</sup> April, 2021. In respect of Tamil Nadu, the wage rate have been revised as Rs.273/- per person per day. The Commissioner of Rural Development and Panchayat Raj has therefore requested the Government to issue necessary orders revising the wage rate with effect from 1<sup>st</sup> April 2021, as Rs.273/- per person per day.

3. The Government have decided to accept the proposal of the Commissioner of Rural Development and Panchayat Raj and to revise the wage rate from

Rs.256/- to Rs.273/- per person per day with effect from 01.04.2021 under Mahatma Gandhi National Rural Employment Guarantee Scheme.
