#### **ORDER:**

In the letter first read above, the Managing Director, Tamil Nadu Corporation for Development of Women Limited has stated that during the year 2020-21, Government of India has approved the Annual Action Plan for a sum of Rs.339.7373 Crore (60% Government of India share Rs.203.8424 Crore + 40% State share Rs.135.8949 Crore). Based on this, budget estimates were fixed for the year 2020-21. The Annual Action Plan allocation of Rs.339.7373 Crore was fully sanctioned by Government of India and State Government and the amount has been received by the Corporation.

2. She has further stated that considering the performance of the State, the Government of India has sanctioned a sum of Rs.85,40,72,000/- being the 60% share of 3<sup>rd</sup> instalment of funds for the year 2020-21 under National Rural Livelihood Mission (NRLM) additionally, over and above the Annual Action Plan allotment vide 2<sup>nd</sup> letter read above. The additional amount was not budgeted during the year 2020-21.

3. The Managing Director, Tamil Nadu Corporation for Development of Women Limited has therefore requested the Government to sanction and release the total amount of Rs.142,34,53,334/- (Rupees One hundred and forty two Crore thirty four lakh fifty three thousand three hundred and thirty four only) i.e., Central release of Rs.85,40,72,000/- and State Share of Rs. 56,93,81,334/-. The details of fund to be released as 60% of Central Share received, along with 40% State share, from the Budget Estimates 2021-22 provisions, as below :
