1. Operational Guidelines of the Ministry of Jal Shakti, Department of Drinking Water and Sanitation, Gol for the implementation of Jal Jeevan Mission issued on 25.12.2019.
2. From the Director of Rural Development and Panchayat Raj, Chennai, Letter Roc. No.4943/2020/PRI.3.2, dated 11.3.2020.

ORDER:

In the letter second read above, the Director of Rural Development and Panchayat Raj has stated that Jal Jeevan Mission is a time bound mission-mode programme which is being implemented to ensure every rural household has a Functional Household Tap Connection (FHTC) by 2024 to provide drinking water in adequate quantity (minimum 55 lpcd) of prescribed quality (BIS:10500) on regular basis.

2. The Director of Rural Development and Panchayat Raj has further stated that during the year 2019-20, Government of India has allocated Rs.371.94 Crore for augmenting water sources and for providing Functional Household Tap Connections for rural areas and for monitoring of the scheme and to coordinate with the stake holders viz., Tamil Nadu Water Supply and Drainage Board, Rural Development and Panchayat Raj Department and Districts and to sort out implementation issues, a State Level Coordination Committee may be constituted. The Director of Rural Development and Panchayat Raj has also sent the functions of the committee.

3. The Government have decided to accept the proposal of the Director of Rural Development and Panchayat Raj and issue orders for the formation of the State Level Co-ordination Committee and functions of the committee as follows:-

i) Constitution of the Committee:

ii) Functions of the Committee:

- 1) The Committee has to prepare a State Specific guidelines in addition to Government of India guidelines both in English and Tamil, for the successful implementation of Jal Jeevan Mission in Tamil Nadu to achieve the goal of providing FHTCs by 2024.
- 2) The State Specific guidelines should enumerate on the following points:
 - a. Vision, Mission and Objectives of Jal Jeevan Mission.
 - b. Strategy for Planning and implementation
 - c. Institutional mechanism (DWSM and VWSC)
 - d. Empanelment of implementation support agencies.
- 3) The committee may design appropriate methodology for identifying the total number of households, households provided with FHTCs and balance FHTCs to be provided.
- 4) The committee shall prescribe the road map, methodology and the persons responsible at the district, block and village level for baseline survey of household tap connections by the districts by 31st March 2020, reporting the same in the IMIS.
- 5) The committee shall be responsible for monitoring, reviewing mechanism and timelines for executing the Jal Jeevan Mission.
- 6) All other works assigned by State Nodal Officer of Jal Jeevan Mission and Mission Director of Jal Jeevan Mission as and when required.
