2. In the order first read above, Ministry of Rural Development have released a sum of Rs.122.21 lakh as 3rd instalment for promotion of enterprise based livelihood in 2 blocks – Thiruporur block of Kancheepuram district and Ulundurpet block of Kallakurichi district of Tamil Nadu during the year 2020-21.

3. In the letter second read above, the Managing Director, Tamil Nadu Corporation for Development of Women Limited has requested the Government to sanction and release a sum of Rs. 2,03,68,333/- Central Share (60%) of Rs.1,22,21,000/- and State Share (40%) Rs.81,47,333/- for Startup Village Entrepreneurship Programme (SVEP) under National Rural Livelihood Mission.

4. The Government after careful examination have decided to accept the proposal of the Managing Director, Tamil Nadu Corporation for Development of Women Limited and hereby accord sanction and release a sum of Rs.2,03,68,333/- (Rupees Two crore three lakh and sixty eighty thousand three hundred and thirty three only) i.e. both 60% of Central Share Rs.1,22,21,000/- and 40% State Share Rs.81,47,333/- towards the 3rd installment for the year 2020-21 under Start up Village Entrepreneurship Programme (SVEP).
