### **ORDER:**

In the Gazette Notification first read above, the Government of India have notified revision of wage rate under Mahatma Gandhi National Rural Employment Guarantee Scheme to all States / Union Territories with effect from 1<sup>st</sup> April, 2021. Accordingly, in the G.O. second read above, the Government have issued orders for revision of wage rate as Rs.273/- with effect from 01.04.2021.

2. In the letter third read above, the Commissioner of Rural Development and Panchayat Raj has stated that from Financial Year 2019-20 onwards, estimates creation and administrative sanction and technical sanction under Mahatma Gandhi NREGS is being done using the SECURE Software, which has been developed and maintained by the National Informatics Centre, Kerala, under the supervision and control of the Ministry of Rural Development, Government of India. Automatic updation of the wage rate from Rs.256 to Rs.273/- per day per person and subsequent revision of rates in SECURE Software have already started from 1<sup>st</sup> April, 2021.

3. The Commissioner of Rural Development and Panchayat Raj has therefore sent the proposal for approval of revised Rural Schedule of Rates for various types of activities to be executed in different types of soil, plantation and differently abled persons for the Financial Year 2021-22 and he has requested the Government to approve the Rural Schedule of Rates for the Financial Year 2022-22 under Mahatma Gandhi National Rural Employment Guarantee Scheme.

4. The Government after careful examination of the proposal of the Commissioner of Rural Development and Panchayat Raj and have decided to accept the same and approve the revised Rural Schedule of Rates for various types of activities to be executed in different types of soil, plantation and differently abled persons for the Financial Year 2021-22 under MGNREGS as in the Annexure – I, II and III of this order.

5. This order is issued with the concurrence of Finance Department vide its U.O.No.18414/Finance(RD)/2021, dated 22.04.2021.

**Persons.**

The special activities identified where the disabled workers were able to work for 8 hours and shall be paid the whole wage rate as applicable:-

<b>Special activities</b>	
1) Watermen / Water women at the worksite, who can distribute water to the workers	<b>Rs.273/- per day per person</b>
2) Caretaker to look after the children	
3) Assisting the caretaker for every 5 child one additional assistant can be employed	
4) Assisting the worksite facilitator in premarking (if the No. of worker is above 100 then 1 disabled person shall be permitted to assist the worksite facilitator)	
5) Watering (Wetting) the area to be desilted (especially in summer)	

**If engaged in minor works related to desilting activities as listed below, the rates for all the items shall be twice that of RSoR fixed for normal persons as noted below:**

1) Clearing uprooted jungle scrub jungle, light jungle	<b>50% of the average outturn of the normal person (Twice the rate that of RSoR fixed for the normal persons)</b>
2) Earthwork in all types of soil	
3) Planting	
4) Watering	
5) Breaking clods, tamping & sectioning	
6) Benching old embankment	
7) Any other works covered under RSoR
