### **ORDER:**

The Hon'ble Minister for Municipal Administration, Rural Development and Implementation of Special Programme has made the following announcement on the floor of the Legislative Assembly on 21.06.2017:-

“மிகவும் பழுதடைந்த நிலையில் உள்ள ஊராட்சி மன்ற கட்டடங்களுக்குப் பதிலாக, மாண்புமிகு இதயதெய்வம் புரட்சித் தலைவி அம்மா அவர்களின் ஆசியுடன், மாண்புமிகு முதலமைச்சர் அவர்களின் ஆணைப்படி, ஒவ்வொன்றும் 15 இலட்சம் ரூபாய் மதிப்பீட்டில் 500 புதிய ஊராட்சி மன்ற கட்டடங்கள், 75 கோடி ரூபாய் மதிப்பீட்டில் கட்டப்படும்.”

2. In the Government order first read above, orders have been issued approving the guidelines for undertaking various infra-structure facilities works under Mahatma Gandhi National Rural Employment Guarantee Scheme including the construction of Village Panchayat Office Buildings.

3. In the letter second read above, the Director of Rural Development and Panchayat Raj has stated that in para 4(1) of the revised schedule-I of Mahatma Gandhi National Rural Employment Guarantee Act 2005, the works which are permitted under Mahatma Gandhi National Rural Employment Guarantee Scheme has been enlisted. Various common infra-structure facilities such as construction of buildings for Gram Panchayats, Women Self Help Group Federations, Cyclone Shelters, Anganwadi Centres, Village Haats and Crematoria, Construction of play fields, Creating infra-structure for promotion of fisheries such as Fish Drying Yards, Storage Facilities, and promotion of fisheries in seasonal water bodies on public land have also been newly added to the list of works that can be taken under Mahatma Gandhi National Rural Employment Guarantee Scheme(MGNREGS) in accordance with the provision of the Act.

4. The Director of Rural Development and Panchayat Raj has stated that it has been proposed to construct 500 Panchayat Office Buildings at a unit cost of Rs.15.00 lakhs as per the Rural Schedule of Rates(RSoR) 2017-18. The total cost of the construction of 500 Panchayat Buildings is Rs.7500 lakh. The material component and labour component ratio for one Village Panchayat Office Building is 91:9 i.e, the material component will be Rs.13.63 lakhs and the labour component will be Rs.1.37 lakh for generating 670 persondays. Thus, for construction of 500 Village Panchayat Buildings 3.35 lakhs of persondays will be generated. The above mandays may vary, in case of deviation during construction.

5. The Director of Rural Development and Panchayat Raj has further informed that the labour and material ratio will be maintained at district level as 60:40 as envisaged in the amendment made to Schedule-I vide Government of India's Notification dated 21.07.2014. The funding pattern for the construction of 500 Village Panchayat Office Buildings under Mahatma Gandhi National Rural Employment Guarantee Scheme for the FY 2017-18 is as follows:-

The Director of Rural Development and Panchayat Raj has therefore requested the orders of the Government for the Construction of 500 Village Panchayat Office Building at an estimated cost of Rs.75 Crore under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2017-18 based on the guidelines issued in G.O.(Ms) No.34, Rural Development and Panchayat Raj(CGS.1) Department, dated 04.03.2014.

7. The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, hereby accord sanction for the construction of 500 Village Panchayat Office Buildings at an estimated cost of Rs.75.00 Crore (Rupees Seventy Five Crore only) under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2017-18 based on the guidelines issued in G.O.(Ms) No.34, Rural Development and Panchayat Raj(CGS.1) Department, dated 04.03.2014, subject to the condition that the financial sanction may be approved after getting the release of Central Share.

8. This order is issued with the concurrence of Finance Department vide its U.O.No.28925/RD/2017, dated 7.6.2017.
