In the Government Orders 1^{st} and 2^{nd} read above orders have been issued for revision of wage rate from Rs.224/- to Rs.229/- per person per day with effect from 01.04.2019.

The Director of Rural Development and Panchayat Raj has stated in his letter 4^{th} read above that now the Government of India has notified revision of wage rate to all States/Union Territories with effect from 1^{st} April, 2020. In respect of Tamil Nadu, the wage has been revised as Rs.256/- per person per day. The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue necessary orders revising the wage rate with effect from 1^{st} April, 2020 as Rs.256/- per person per day.
