In the Government Orders 1st and 2nd read above orders have been issued for revision of wage rate from Rs.224/- to Rs.229/- per person per day with effect from 01.04.2019.

The Director of Rural Development and Panchayat Raj has stated in his letter 4th read above that now the Government of India has notified revision of wage rate to all States/Union Territories with effect from 1st April, 2020. In respect of Tamil Nadu, the wage has been revised as Rs.256/- per person per day. The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue necessary orders revising the wage rate with effect from 1st April, 2020 as Rs.256/- per person per day.

3. The Government have decided to accept the proposal of the DRD&PR and issue orders for revision of Wage Rate from Rs.229/- to Rs.256/- per person per day with effect from 01.04.2020 under MGNREGS.
