Mahatma Gandhi National Rural Employment Guarantee Scheme - Computer Assistants appointed under Mahatma Gandhi National Rural Employment Guarantee Scheme and other Scheme Works - Consolidated pay - Increased - Orders issued.

ORDER:

The Director of Rural Development and Panchayat Raj in the letter read above, has stated that Mahatma Gandhi National Rural Employment Guarantee Scheme(MGNREGS) is being implemented in all the 31 districts in 3 phases starting from 02.02.2006. Implementation and monitoring of MGNREGS has been done through Management Information System(MIS) which is effectively carried out by 1,789 Computer Assistants appointed through following methods:

 Computer Assistants recruited under Mahatma Gandhi National Rural Employment Guarantee Scheme through Employment Exchange working on consolidated pay;

and

- Computer Assistants engaged through Outsourcing, on consolidated pay.
- 2. The Director of Rural Development and Panchayat Raj has also stated that Representation has been received from that Mahatma Gandhi National Rural Employment Guarantee Scheme Computer Assistants to increase their monthly consolidated pay commensurating with the increase of wages of the MGNREGS workers. In this regard, as per the G.O.(Ms) No.71, Rural Development and Panchyat Raj(CGS1) Department, dated 20.6.2014, the Computer Assistants are drawing a consolidated pay of Rs.11,000/- per month from 2014 onwards based on the wage rate notification of Rs.148/- for MGNREGS workers with effect from 01.04.2013 by Government of India based on Consumer Price Index(CPI). In the above said Order it has also been directed that the Director of Rural Development and Panchayat Raj to get prior concurrence of the Government for subsequent revision of the consolidated pay of Computer Assistants.
- 3. The Director of Rural Development and Panchayat Raj has further stated that as the wage of MGNREGS workers has increased from Rs.148/- to Rs.203/-, the consolidated pay of the Computer Assistants may also be increased at the rate of Rs.500/- Per Annum for 4 Years from 2014 to 2017 (i.e. Rs.500X4= Rs.2000/-) to the

tune of Rs.2000/-. He has also suggested that on the basis of increase in the Wage Rate notified for MGNREGS workers, the consolidated pay of 1,789 Computer Assistants may be increased from Rs.11,000/- to Rs.13,000/- per month, from the date of issue of Government Order. Further, in the G.O.(Ms) No.37, Rural Development and Panchyat Raj(E5) Department, dated 22.3.2017, Government has issued orders to absorb 906 Computer Assistants as Junior Assistants by conducting a special qualifying test by TNPSC. So, the 906 Computer Assistants recruited through Employment Exchange may be ordered to get the enhanced Consolidated Pay till their date of absorption as Junior Assistants into Government service. The additional cost can be met from 6% administrative component under MGNREGS and the revised consolidated pay may be given effect from the date of issue of Government Order. Hence, the Director of Rural Development and Panchayat Raj has requested early orders of the Government in this regard.

- 4. The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, direct that the consolidated pay for 1,789 Computer Assistants appointed under various channels for Mahatma Gandhi National Rural Employment Guarantee Scheme and other scheme works be increased from Rs.11,000/- to Rs.12,000/- (Rupees twelve thousand only) per month under administrative component of Mahatma Gandhi National Rural Employment Guarantee Scheme from the date of issue of this Government Order.
- 5. The Government also direct that the Director of Rural Development and Panchayat Raj to get the prior concurrence of the Government for the subsequent revision of the consolidated pay of the Computer Assistants.
- 6. This order is issued with the concurrence of Finance Department vide its U.O.No.25610/Fin(RD)/2017, dated 22.6.2017.
