## **ORDER:**

In the letter third read above the Director of Rural Development and Panchayat Raj has stated that the Empowered Committee has agreed to the Labour Budget of 27 crore persondays for the State of Tamil Nadu for the financial year 2020-21 and the MoRD, Gol has released mother sanction order for Rs.199577.90 lakh for wages under MGNREGS during 2020-21.

2) The Director of Rural Development and Panchayat Raj has further stated that now the Government of India in the letter second read above have sanctioned a sum of Rs.665,75,55,000/- (Rupees Six Hundred and Sixty Five Crore Seventy Five lakh Fifty Five Thousand Only) towards Material component and Admin component as 1<sup>st</sup> installment of 1<sup>st</sup> Tranche of Central Assistance for implementation of the MGNREGA for the financial year 2020-21 on condition that the State Government must transfer these funds along with the State share to the State Employment Guarantee Fund for programme implementation within 3 days of receipt of funds failing which the State Government would be liable to pay a penal interest of 12% for the period of delay beyond the specified period. The expenditure per person-day generation of wage employment shall have wage and material costs in the proportion of 60:40. The cost of

wages is 100% borne by Government of India and as per Rule 22(1)(b) and (2)(b) of the NREGA Act 2005 the expenditure on material component including wages of skilled and semi-skilled labour will be shared between Centre and State Government in the ratio of 75:25. The administrative cost is 100% borne by Government of India.

- 3) The Director of Rural Development and Panchayat Raj has therefore requested the Government to sanction a sum of Rs.554,79,62,500/- (Rupees Five Hundred Fifty Four Crore Seventy Nine Lakh Sixty Two Thousand and Five Hundred Only) towards Material component as 1<sup>st</sup> installment of 1<sup>st</sup> tranche of Central Assistance for the year 2020-21 along with the proportionate State Share to Rs.184,93,20,833/- (Rupees One Hundred and Eighty Four Crore Ninety Three Lakh Twenty Thousand Eight Hundred and Thirty Three only) and Rs.110,95,92,500/- (Rupees One Hundred and Ten Crore Ninety Five Lakh Ninety Two Thousand and Five Hundred Only) towards Admin cost, totaling Rs.850,68,75,833/- (Rupees Eight Hundred and Fifty Crore Sixty Eight Lakh Seventy Five Thousand Eight Hundred and Thirty Three only) for the year 2020-21 and to permit him to draw and disburse the amount to the State Employment Guarantee Fund of Tamil Nadu.
- 4) The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction a sum of Rs.554,79,62,500/-(Rupees Five Hundred Fifty Four Crore Seventy Nine Lakh Sixty Two Thousand and Five Hundred Only) towards Material component as 1<sup>st</sup> installment of 1<sup>st</sup> tranche of Central Assistance along with the proportionate State Share to Rs.184,93,20,833/- (Rupees One Hundred and Eighty Four Crore Ninety Three Lakh Twenty Thousand Eight Hundred and Thirty Three only) and Rs.110,95,92,500/- (Rupees One Hundred and Ten Crore Ninety Five Lakh Ninety Two Thousand and Five Hundred Only) towards Admin cost, totaling Rs.850,68,75,833/- (Rupees Eight Hundred and Fifty Crore Sixty Eight Lakh Seventy Five Thousand Eight Hundred and Thirty Three only) under MGNREGA for the year 2020-21.
- 5) The expenditure sanctioned in para 4 above shall be debited to the following head of account:
