

## **ABSTRACT**

Mahatma Gandhi National Rural Employment Guarantee Act Payment of 4<sup>th</sup> installment of 1<sup>st</sup> tranche of Central Assistance of Material and administrative Component released by Government of India - Sanction a sum of Rs.112,04,80,000/- under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2017-18- Sanction accorded – Orders- Issued.

## ORDER:

In the letter read above, the Director of Rural Development and Panchayat Rai has stated that the Empowered Committee after scrutiny has agreed to the Labour Budget proposal of 23.33 Crore persondays for the State of Tamil Nadu for the year 2017-18 in the Letter No:J-12034/2/2017-MGNREGS-VI, SI.No.16(NeFMS), dated 10.4.2017, Sl.No.31(NeFMS) dated 21.07.17 and Sl.No.47(NeFMS), dated 21.07.2017 Government of India have released a sum of Rs.3934.90 crore as Mother Sanction order to the Ne-FMS account for implementation of National Electronic Fund Management System (NeFMS) under MGNREGA towards Wage Component for the financial year 2017-18 out of which a sum of Rs.3752.99 crore has been released so far. Further, a sum of Rs.141.7976 crore (Rs.70.8988 crore + Rs.70.8988 crore) has been released by Government of India as 2<sup>nd</sup> and 3<sup>rd</sup> part of 1st Tranche of Central Assistance towards material component vide Lr.No.J-12034/2/2017-MGNREGS-VI, SI.No.47(NeFMS), dated 26.5.2017 and Letter F.No.J-12034/2/2017-MGNREGA-VI, SI.No.69, dated 30.06.2017 Subsequently, Government vide G.O.(Ms) No.65, Rural Development and Panchayat Raj(CGS.1) Department, dated 16.6.2017 and G.O.(Ms) No.89, Rural Development and Panchayat Raj(CGS.1) Department, dated 01.8.2017 have sanctioned a sum of Rs.141.7976 crore (Rs.70.8988 crore + Rs.70.8988 crore) towards Material component being 2<sup>nd</sup> and 3<sup>rd</sup> part of 1<sup>st</sup> tranche of Central Assistance along with the proportionate 25% State Share of Rs.47.26 Crore (Rs.23.63 crore + Rs.23.63 Crore) respectively for the year 2017-18 under MGNREGS respectively.

- 2. The Director of Rural Development and Panchayat Raj has also stated that the Government of India in Lr.F.No.J-12034/2/2017-MGNREGA-VI SI.No.98 dated 21.7.2017 have sanctioned a sum of Rs.93,04,80,000/- (Rupees Ninety three crore four lakh and eighty thousand only) to the State Government of Tamil Nadu as 4<sup>th</sup> installment of 1<sup>st</sup> Tranche of Central Assistance towards Material and Admin component on condition that the State Government must transfer these funds along with the State share to the State Employment Guarantee Fund for programme implementation within 3 days of receipt of funds failing which the State Government would be liable to pay a penal interest of 12% for the period of delay beyond the specified period.
- 3. The Director of Rural Development and Panchayat Raj has further stated that in the email received from Government of India dated 16.08.2017, Government of India have informed that out of the above release, a sum of Rs.57.00 crore was released for Material component and a sum of Rs.36 crore was released towards admin expenditure. Further, as per para 3(f) of the above Government of India order, it has been ordered that the expenditure of material component including wages of skilled and semi-skilled labour will be shared between Centre and State Government in the ratio of 75:25 in accordance with Rule 22(1)(b) and (2)(b) of the NREGA Act 2005. Therefore, taking into account of the above release of material component as 75% share of Government of India, the State has to bear the balance 25% of the cost of the material component which amounts to Rs.19,00,00,000/-
- 4. The Director of Rural Development and Panchayat Raj has therefore requested the order of the Government on the following:-
  - to sanction a sum of Rs.76,00,00,000/- (Rupees Seventy six crore only) towards Material component as 4<sup>th</sup> installment of 1<sup>st</sup> tranche of Central Assistance alongwith the proportionate State Share for the year 2017-18 towards Material component along with 6% of admin cost Rs.36,04,80,000/- total amount of Rs.112,04,80,000/- crore sanctioned by Gol and state share under Mahatma Gandhi National Rural Employment Guarantee Scheme.
  - to permit the Director of Rural Development and Panchayat Raj to draw and transfer the amount to the State Employment Guarantee Fund of Tamil Nadu.
- 5. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction for a sum of Rs.112,04,80,000/- (Rupees One hundred and twelve crores four lakhs eighty thousand only) towards Material Component and Administrative component as 4<sup>th</sup> installment of 1<sup>st</sup> tranche of Central Share along with proportionate State Share under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2017-18.

6. The expenditure sanctioned in para 5 above shall be debited to the following head of account:
